If the Federal Circuit Court of Australia makes an order when exercising jurisdiction over a Commonwealth tenancy dispute involving land in the Jervis Bay Territory:

- (a) the Federal Circuit Court of Australia may exercise any powers of the ACT Civil and Administrative Tribunal under the applicable Jervis Bay Territory law; and
- (b) a Registrar of the Federal Circuit Court of Australia may exercise any powers of a registrar of the ACT Civil and Administrative Tribunal; to the extent that those powers are relevant to the execution or enforcement of

Add:

21 Powers when executing orders made by the Court

If the Federal Circuit Court of Australia makes an order when exercising jurisdiction over a Commonwealth tenancy dispute involving land in the Jervis Bay Territory:

- (a) the Federal Circuit Court of Australia may exercise any powers of the ACT Civil and Administrative Tribunal under the applicable Jervis Bay Territory law; and
- (b) a Registrar of the Federal Circuit Court of Australia may exercise any powers of a registrar of the ACT Civil and Administrative Tribunal; to the extent that those powers are relevant to the execution or enforcement of the order.

50 Application of amendments

The amendments made by the *Federal Circuit Court (Commonwealth Tenancy Disputes) Amendment Instrument 2017* apply in relation to Commonwealth tenancy disputes arising before or after the commencement of that instrument.
