Schedule 1—Repeals

Australian Grape and Wine Authority Regulations 1981

1 The whole of the instrument

Repeal the instrument.

Schedule 2—Amendments

Primary Industries (Customs) Charges Regulations 2000

1 Clause 1 of Schedule 13

Omit “*Australian Grape and Wine Authority Act 2013*”, substitute “*Wine Australia Act 2013*”.

2 Clause 1 of Schedule 13 (note)

Omit “regulation 12 of the *Australian Grape and Wine Authority Regulations 1981*”, substitute “section 28 of the *Wine Australia Regulations 2018*”.

Primary Industries Levies and Charges Collection Regulations 1991

3 Clause 2 of Schedule 35 (definition of *Authority*)

Omit “the Australian Grape and Wine Authority”, substitute “Wine Australia”.

4 Clause 2 of Schedule 35 (definition of *licence*)

Omit “regulation 5 of the *Australian Grape and Wine Authority Regulations 1981*”, substitute “section 9 of the *Wine Australia Regulations 2018*”.
