1 Name

- (1) This instrument is the Migration (IMMI 18/076: Arrangements for Other Family Visa Applications and New Zealand (Family Relationship) Visa Applications) Instrument 2018.
- (2) This instrument may also be cited as IMMI 18/076.

3 Authority

This instrument is made under subregulation 2.07(5) of the *Migration Regulations* 1994.

4 Definitions

- (1) For the purposes of item 1123A of Schedule 1 to the Regulations, the approved form in Column B of the table in Schedule 1 is specified.
- (2) For the purposes of paragraph 1123A(3)(a) of Schedule 1 to the Regulations, the place and the way in which an application must be made is specified in Column C in the table in Schedule 1.

7 Making an application—Other Family (Residence) (Class BU) visa

- (1) For the purposes of item 1123B of Schedule 1 to the Regulations, the approved form in Column B of the table in Schedule 2 is specified.
- (2) For the purposes of paragraph 1123B(3)(a) of Schedule 1 to the Regulations, the place and the way in which an application must be made is specified in Column C in the table in Schedule 2.

8 Making an application—New Zealand (Family Relationship) (Temporary) (Class UP) visa

- (1) For the purposes of item 1214BA of Schedule 1 to the Regulations, the approved form in Column B of the table in Schedule 3 is specified.
- (2) For the purposes of paragraph 1214BA(3)(a) of Schedule 1 to the Regulations, the place and the way in which an application must be made is specified in Column C in the table in Schedule 3.
