#### 1 Name

This instrument is the Offshore Minerals (Registration Fees) Regulations 2018.

#### 2 Commencement

#### **5** Definitions

In this instrument:

Act means the Offshore Minerals (Registration Fees) Act 1981.

#### 6 Registration fees

Prescribed percentage of value

(1) For the purposes of subsection 4(1) of the Act, 1.5% is prescribed.

Minimum amount of fee

(2) For the purposes of subsection 4(2) of the Act, \$600 is prescribed.

(3) For the purposes of a provision of the Act specified in column 1 of an item of the following table, the amount specified in column 2 of the item is prescribed.
