1 Name

This instrument is the *Criminal Code (Terrorist Organisation—Al-Qa’ida) Regulations 2019*.

2 Commencement

5 Terrorist organisation—Al-Qa’ida

- (1) For the purposes of paragraph (b) of the definition of **terrorist organisation** in subsection 102.1(1) of the *Criminal Code*, the organisation known as Al-Qa’ida is specified.
- (2) Al-Qa’ida is also known by the following names:
- Al-Jihad al-Qaeda;
 - Al Qaeda;
 - Al-Qaeda;
 - Al-Qaida;
 - AQ;
 - The Base;
 - The Group for the Preservation of the Holy Sites;
 - International Front for Fighting Jews and Crusaders;

- (i) Islamic Army;
- (j) The Islamic Army for the Liberation of Holy Places;
- (k) Islamic Army for the Liberation of Holy Sites;
- (l) Islamic Salvation Foundation;
- (m) The Jihad Group;
- (n) New Jihad;
- (o) Usama Bin Laden Network;
- (p) Usama Bin Laden Organisation;
- (q) The World Islamic Front for Jihad against Jews and Crusaders.
