1 Name

Schedule 1—Amendments

Proclamation under Seas and Submerged Lands Act 1973

1 Paragraph (d)

Omit “paragraphs 2(a) to (z) and (zfa) to (zzf)”, substitute “subitems 2(1) and (3)”.

2 Paragraph (da)

Omit “paragraphs 2(za) to (zf)”, substitute “subitem 2(2)”.

3 Item 2 of the Schedule

Omit “The line:”.

4 Before paragraph 2(a) of the Schedule (after the subitem heading)

Insert:

(1) The line:

5 After paragraph 2(x) of the Schedule

Insert:

(xa) then north-easterly along the geodesic to the point of Latitude 11°24′05.7062″S, Longitude 126°18′18.0723″E;

6 Paragraph 2(z) of the Schedule

Repeal the paragraph, substitute:

(z) then north-easterly along the geodesic to the point of Latitude 11°20′05.0996″S, Longitude 126°30′55.5968″E and continuing from this point south-easterly along the geodesic to the point identified in paragraph (2)(za).

7 Before paragraph 2(za) of the Schedule (after the subitem heading)

Insert:

(2) The line:

8 Paragraph 2(za) of the Schedule

Repeal the paragraph, substitute:

(za) commencing at the point of Latitude 11°20′02.90″S, Longitude 126°31′58.40″E;

9 Paragraph 2(zf) of the Schedule

Omit “E;”, substitute “E.”.

10 Before paragraph 2(zfa) of the Schedule (after the subitem heading)

Insert:

(3) The line:

11 Paragraph 2(zfa) of the Schedule

Repeal the paragraph, substitute:

(zfa) continuing, from the point identified in paragraph (2)(zf), north-easterly along the geodesic to the point of Latitude 10°28'05.1256"S, Longitude 128°13'55.6444"E;

12 Paragraph 3(zi) of the Schedule

Omit "Longitude 156°37'00'E", substitute "Longitude 156°37'00"E".

13 Paragraph 4(x) of the Schedule

After "Longitude 169°25'54'", insert "E".
