Part 1—Preliminary

1 Name

- (1) This instrument is the *Migration (LIN 19/209: Arrangements for Certain Skilled and Temporary Graduate Visa Applications) Instrument 2019*.
- (2) This instrument may be cited as LIN 19/209.

2 Commencement

The whole of this instrument commences at the same time as Schedule 1 to the *Migration Amendment (New Skilled Regional Visas) Regulations 2019*.

3 Authority

This instrument is made under subregulation 2.07(5) of the *Migration Regulations 1994* (the Regulations).

4 Schedules

The instrument that is specified in Schedule 1 to this instrument is repealed as set out in the applicable items in the Schedule concerned, and has effect according to its terms.

5 Form, place and manner for making an application

- (a) the form mentioned in column 4 of the item is specified; and
