(4A) However, for the purposes of subsection 4(1B) of the Act, the annual charges in respect of the inclusion of the following kinds of medical devices (other than medical devices produced for export) in the Register under Chapter 4 of the *Therapeutic Goods Act 1989* that has effect at any time during the charge year that starts on 1 July 2020 are as follows:

- (a) for a Class IIa medical device, or Class IIb medical device, that is a listed prosthesis within the meaning of the *Private Health Insurance (Prostheses) Rules (No. 1) 2020* as in force on 8 April 2020—\$470;
- (b) for a Class AIMD medical device, or Class III medical device, that is a listed prosthesis within the meaning of the *Private Health Insurance (Prostheses) Rules (No. 1) 2020* as in force on 8 April 2020—\$600.
