



1 Name

This instrument is the Financial Framework (Supplementary Powers) Amendment (Infrastructure, Transport, Regional Development and Communications Measures No. 6) Regulations 2020.

Schedule 1—Amendments

Financial Framework (Supplementary Powers) Regulations 1997

1 In the appropriate position in Part 4 of Schedule 1AB (table)

Insert:

424 Local Roads and Community Infrastructure Program To provide financial assistance to:

- (a) local government bodies, and similar bodies responsible for providing local community services and infrastructure; and
- (b) States and Territories;

for the construction, maintenance or improvement of:

- (c) roads and associated facilities; and
- (d) community infrastructure;

as a measure to support recovery from the adverse effects of the national crisis resulting from the coronavirus known as COVID-19.

This objective also has the effect it would have if it were limited to measures:

- (a) with respect to trade and commerce with other countries, or among the States and Territories; or
- (b) with respect to postal, telegraphic, telephonic, and other like services (within the meaning of paragraph 51(v) of the Constitution); or
- (c) for, or in relation to, Indigenous Australians or particular groups of Indigenous Australians; or
- (d) to give effect to Australia's obligations under either or both of the following:
 - (i) the International Covenant on Economic, Social and Cultural Rights, particularly Articles 2 and 6;
 - (ii) the International Labour Organization's Convention concerning Employment Policy, particularly Articles 1 and 2; or
- (e) involving the granting of financial assistance to a State or Territory; or
- (f) undertaken in, or in relation to, a Territory.
