Part 1—Amendment of the Bankruptcy Act 2006 (Norfolk Island)

Norfolk Island Continued Laws Ordinance 2015

Omit “the day on which the *Norfolk Island Continued Laws Amendment (Coronavirus Economic Response Measures) Rules 2020* commences and ending on 25 September 2020”, substitute “21 July 2020 and ending on 31 December 2020”.

Omit “26 September 2020” (wherever occurring), substitute “1 January 2021”.

3 Item 38A of Schedule 1 (definition of COVID-19 period in section 6)

Omit “the day on which the *Norfolk Island Continued Laws Amendment (Coronavirus Economic Response Measures) Rules 2020* commences and ending on 25 September 2020”, substitute “21 July 2020 and ending on 31 December 2020”.

4 Item 42AB of Schedule 1 (section 678)

Omit “6 November 2020”, substitute “22 March 2021”.

5 Division 19 of Part 2 of Schedule 1 (heading)

Repeal the heading, substitute:
