## About this compilation

### This compilation

This is a compilation of the *Higher Education Support (Maximum Payments for Other Grants) Determination 2020* that shows the text of the law as amended and in force on 22 December 2022 (the **compilation date**).

## 6 Determination of maximum payments

For the purposes of item 13 of the table in subsection 41-45(1) of the Act, the total payments made under Part 2-3 of the Act in respect of a year referred to below must not exceed the amount specified:

- (a) for the year 2020—\$1,784,061,000;
- (b) for the year 2021—\$3,276,103,423;
- (c) for the year 2022— \$2,265,000,000;
- (d) for the year 2023— \$2,412,000,000; and
- (e) for the year 2024—\$2,241,533,000.

### Legislation history and amendment history—Endnotes 3 and 4

Amending laws are annotated in the legislation history and amendment history.

The legislation history in endnote 3 provides information about each law that has amended (or will amend) the compiled law. The information includes commencement details for amending laws and details of any application, saving or transitional provisions that are not included in this compilation.

The amendment history in endnote 4 provides information about amendments at the provision (generally section or equivalent) level. It also includes information about any provision of the compiled law that has been repealed in accordance with a provision of the law.

### Misdescribed amendments

A misdescribed amendment is an amendment that does not accurately describe how an amendment is to be made. If, despite the misdescription, the amendment can be given effect as intended, then the misdescribed amendment can be incorporated through an editorial change made under section 15V of the *Legislation Act 2003*.

If a misdescribed amendment cannot be given effect as intended, the amendment is not incorporated and “(md not incorp)” is added to the amendment history.
