Schedule 1—Amendments

Part 1—Boric acid

Poisons Standard February 2021

1 Schedule 5 of Part 4 of Schedule 1 (entry for boric acid)

Repeal the entry, substitute:

BORIC ACID except:

- a) when included in Schedule 4; or
- b) in cosmetic hand cleaning preparations when labelled with a warning to the following effect:
 - NOT TO BE USED FOR CHILDREN UNDER 3 YEARS OF AGE; and if the concentration of free soluble borates exceeds 1.5 per cent (as boric acid), with the words: NOT TO BE USED ON PEELING OR IRRITATED SKIN; or
- c) in cosmetic talc preparations containing 5 per cent or less calculated as boric acid when labelled with a warning to the following effect:
 - NOT TO BE USED FOR CHILDREN UNDER 3 YEARS OF AGE; and if the concentration of free soluble borates exceeds 1.5 per cent (as boric acid), with the words: NOT TO BE USED ON PEELING OR IRRITATED SKIN; or
- d) in cosmetic oral hygiene preparations containing 0.1 per cent or less calculated as boric acid when labelled with a warning to the following effect:
 - NOT TO BE SWALLOWED. NOT TO BE USED FOR CHILDREN UNDER 3 YEARS OF AGE; or
- e) in other cosmetic preparations containing 3 per cent or less calculated as boric acid when labelled with a warning to the following effect:
 - NOT TO BE USED FOR CHILDREN UNDER 3 YEARS OF AGE; and if the concentration of free soluble borates exceeds 1.5 per cent (as boric acid), with the words: NOT TO BE USED ON PEELING OR IRRITATED SKIN; or
- f) in preparations, other than insect baits, containing 6 per cent or less calculated as boric acid.
