Defence Determination 2016/19, Conditions of service

1 Offsetting assisted leave travel

- 1. This section applies to a member on a long-term posting overseas who was required to pay for COVID-19 testing for their school-age dependant between 01 January 2021 and the commencement of this Schedule.
- 2. The member is eligible to be reimbursed the cost of one COVID-19 test each school term if the school made a COVID-19 test a mandatory requirement for the school-age dependant to attend the school.
