Amendment of List of Exempt Native Specimens – Queensland Coral Fishery, June 2021

I, SIMON BANKS, Acting First Assistant Secretary, Heritage, Reef and Wildlife Trade Division, as Delegate of the Minister for the Environment, pursuant to subsection 303DC(1)(a) of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act), hereby amend the list of exempt native specimens established under section 303DB of the EPBC Act by **deleting** from the list specimens and any notations specified in **Schedule 1**, and by **including** in the list specimens and associated restrictions or conditions as set out in **Schedule 2**.
