#### Part 1—Preliminary

#### 1 Name of legislative instrument

This is the ASIC Market Integrity Rules (Securities Markets) Determination 2021/772.

#### 2 Commencement

This instrument commences on the later of:

- (a) 11 October 2021; and
- (b) 20 business days after the day this instrument is registered on the Federal Register of Legislation.

#### 3 Authority

This instrument is made under subrule 6.2.1(4) of the ASIC Market Integrity Rules (Securities Markets) 2017 (Rules).

#### 4 Interpretation

- (1) In this instrument, unless the contrary intention appears, capitalised terms have the same meaning as in the Rules.
- (2) In this instrument, *stock code*, in relation to an Equity Market Product, means the unique symbol assigned to the Equity Market Product under Rule 9.2.3 of the Rules.

#### Part 2—Determination

#### 5 Tier 1 Equity Market Products and Tier 2 Equity Market Products

- (1) Each Equity Market Product whose stock code is set out in the table in Schedule 1 to this instrument is a Tier 1 Equity Market Product.
- (2) Each Equity Market Product whose stock code is set out in the table in Schedule 2 to this instrument is a Tier 2 Equity Market Product.
