This clause describes the lockdown area within the meaning of the COVID-19 Directions (No. 20) 2022: Directions to lock down Elcho Island including Galiwinku and Wessel Islands including Martjanba (NT), as in force at the commencement of the *Biosecurity (Emergency Requirements—Remote Communities) Amendment Determination (No. 1) 2022*.
