Amendment of List of Exempt Native Specimens – Northern Territory Offshore Net and Line Fishery, March 2022

I, ADAM SINCOCK, Principal Director, Wildlife Trade Office, as Delegate of the Minister for the Environment, pursuant to subsection 303DC(1)(a) of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act), hereby amend the list of exempt native specimens established under section 303DB of the EPBC Act by **deleting** from the list specimens and any associated notations specified in **Schedule 1**, and by **including** in the list specimens and associated notations specified in **Schedule 2**.

This instrument is a legislative instrument for the purposes of the Legislation Act 2003.
