Add:

5	Little Paradise	The parcel of land on Groote Eylandt with an area of 5.85 hectares, more or less, being Northern Territory Portion 7997(A), delineated on Survey Plan S2022/018
6	Malkala	The parcel of land on Groote Eylandt with an area of 14.26 hectares, more or less, being Northern Territory Portion 7998(A), delineated on Survey Plan S2022/019
7	Bartalumba Bay	The parcel of land on Groote Eylandt with an area of 7.86 hectares, more or less, being Northern Territory Portion 7999(A), delineated on Survey Plan S2022/020
