## Schedule 1—Amendments

### *Illegal Logging Prohibition Regulation 2012*

#### **1 Clause 2 of Schedule 2 (table item 4)**

Omit “3 October 2014”, substitute “19 December 2022”.

#### **2 Clause 2 of Schedule 2 (note)**

Repeal the note, substitute:

#### **5 Clause 3 of Schedule 2 (table item 2A)**

Omit “16 June 2015”, substitute “29 June 2022”.

#### **6 Clause 3 of Schedule 2 (table item 3)**

Omit “10 October 2014”, substitute “26 October 2022”.

#### **7 Clause 3 of Schedule 2 (note)**

Repeal the note, substitute:
