**1 Subsection 5(1) (table items 1 to 4)**

Repeal the items, substitute:

1	Heavy vehicle	(a) first examination—\$262.70; (b) subsequent examination—\$152.55
2	Trailer without brakes, motor cycle, motor carrier	(a) first examination—\$163.05; (b) subsequent examination—\$128.95
3	Vehicle not covered by table item 1 or 2	(a) first examination—\$205.00; (b) subsequent examination—\$134.20
4	Any vehicle covered by table item 1, 2 or 3	verifying the vehicle’s identity or specifications— \$144.70
