*container* has the same meaning as in the *Biosecurity Regulation 2016*.

*non-commercial vessel waste* means waste carried on a non-commercial vessel.

#### **2 Section 4 (definition of *general goods*)**

Omit “(as defined by section 19 of the Act)”.

#### **3 Section 4 (definition of *waste*)**

Omit “(as defined by section 19 of the Act)”.

#### **4 Section 8 (cell at table item 2, Column 2 headed “Areas”)**

Repeal the cell, substitute:
