

## 2. Section 3.3.1 Background

Omit paragraph 2 and substitute with the following:

For the foreseeable future, urban land in Metropolitan Canberra will comprise:

- the towns of Canberra Central, Woden/Weston Creek, Belconnen, Tuggeranong, Gungahlin and Molonglo Valley
- the villages of Hall, Oaks Estate and Tharwa
- land at Hume, Mitchell and Fyshwick.

#### 3. Section 3.3.3 Policies for Urban Areas

Omit point a. and replace with the following:

- a. The urban area of Canberra will comprise:
  - the towns of Canberra Central, Woden/Weston Creek, Belconnen,
    Tuggeranong, Gungahlin and Molonglo Valley
  - the villages of Hall, Oaks Estate and Tharwa
  - land at Hume, Mitchell and Fyshwick.


