1 Name

Schedule 1—Amendments

Financial Framework (Supplementary Powers) Regulations 1997

1 In the appropriate position in Part 3 of Schedule 1AB (table)

Insert:

84 Grant to the National
Aboriginal and Torres Strait
Islander Education
Corporation

To provide funding to the National Aboriginal and Torres Strait Islander Education Corporation to support its role as the national education peak body for Aboriginal and Torres Strait Islander people.

This purpose has the effect it would have if it were limited to measures:

- (a) with respect to Indigenous Australians and particular groups of Indigenous Australians; or
- (b) undertaken in the exercise of, or which are incidental to, the executive power of the Commonwealth.

2 Part 4 of Schedule 1AB (table item 460, column headed "Program")

Omit "for Regional and Remote School Leavers".

3 Part 4 of Schedule 1AB (table item 460, column headed "Objective(s)")

Omit "in the year immediately following their completion of the final year of secondary school".
