

EXPLANATORY STATEMENT

STATEMENT OF PRINCIPLES CONCERNING SUICIDE AND ATTEMPTED SUICIDE (REASONABLE HYPOTHESIS) (NO. 39 OF 2025)

VETERANS' ENTITLEMENTS ACT 1986 MILITARY REHABILITATION AND COMPENSATION ACT 2004

1. This is the Explanatory Statement to the *Statement of Principles concerning suicide and attempted suicide (Reasonable Hypothesis)* (No. 39 of 2025).

Background

- The Repatriation Medical Authority (the Authority), under subsection 196B(8) of the *Veterans' Entitlements Act 1986* (the VEA), repeals Instrument No. 65 of 2016 (Federal Register of Legislation No. F2016L01145) determined under subsections 196B(2) and (8) of the VEA concerning suicide and attempted suicide.
- 3. The Authority is of the view that there is sound medical-scientific evidence that indicates that **suicide and attempted suicide** and **death from suicide and attempted suicide** can be related to particular kinds of service. The Authority has therefore determined pursuant to subsection 196B(2) of the VEA a Statement of Principles concerning **suicide and attempted suicide** (Reasonable Hypothesis) (No. 39 of 2025). This Instrument will in effect replace the repealed Statement of Principles.

Purpose and Operation

- 4. The Statement of Principles will be applied in determining claims under the VEA and the *Military Rehabilitation and Compensation Act 2004* (the MRCA).
- 5. The Statement of Principles sets out the factors that must as a minimum exist, and which of those factors must be related to the following kinds of service rendered by a person:
 - operational service under the VEA;
 - peacekeeping service under the VEA;
 - hazardous service under the VEA;
 - British nuclear test defence service under the VEA;
 - warlike service under the MRCA;
 - non-warlike service under the MRCA,

before it can be said that a reasonable hypothesis has been raised connecting **suicide and attempted suicide** or death from **suicide and attempted suicide**, with the circumstances of that service. The Statement of Principles has been determined for the purposes of both the VEA and the MRCA.

6. This Instrument results from an investigation notified by the Authority in the Government Notices Gazette of 25 June 2024 concerning suicide and attempted suicide

in accordance with section 196G of the VEA. The investigation involved an examination of the sound medical-scientific evidence now available to the Authority, including the sound medical-scientific evidence it has previously considered.

- 7. The contents of this Instrument are in similar terms as the repealed Instrument. Comparing this Instrument and the repealed Instrument, the differences include:
 - specifying a day of commencement for the Instrument in section 2;
 - revising the definition of 'suicide and attempted suicide' in subsection 7(2);
 - revising the factor in subsection 9(2) concerning having one of the following clinically significant disorders of mental health;
 - revising the factor in subsection 9(5) concerning having a person with whom one has a close family bond or a close personal relationship experience a category 1A stressor;
 - revising the factor in subsection 9(6) concerning experiencing the death of a person with whom one has a close family bond or a close personal relationship;
 - revising the factor in subsection 9(9) concerning experiencing the suicide of an individual of a similar age;
 - revising the factor in subsection 9(13) concerning having experienced as a child (under the age of 18) one of the following;
 - revising the factor in subsection 9(14) concerning performing a self-injurious act;
 - revising the factor in subsection 9(15) concerning having a medical illness or injury which has resulted in a severe level of disability;
 - revising the factor in subsection 9(17) concerning having persistent pain;
 - revising the factor in subsection 9(19) concerning commencing a course of antidepressant therapy;
 - revising the factor in subsection 9(20) concerning taking any of the following medications;
 - new factor in subsection 9(24) concerning having a concussion;
 - revising the factor in subsection 9(26) concerning residential aged care;
 - new factor in subsection 9(27) concerning experiencing a potentially morally injurious event;
 - new factor in subsection 9(28) concerning experiencing intimate partner violence;
 - new definitions of 'intimate partner violence', 'intimate partner', 'intimate relationship', 'potentially morally injurious event' and 'witness' in Schedule 1 Dictionary;
 - revising the definitions of 'category 1B stressor', 'category 2 stressor', and 'clinically significant disorder of mental health' in Schedule 1 Dictionary; and
 - deleting the definitions of 'bariatric surgery', 'corpse', 'eyewitness', 'peer', 'performing a self-injurious act', 'persistent pain as specified', 'severe childhood abuse', 'severe level of disability', 'significant other' and 'specified list of drugs'.

Consultation

8. Prior to determining this Instrument, the Authority advertised its intention to undertake an investigation in relation to **suicide and attempted suicide** in the Government Notices Gazette of 25 June 2024, and circulated a copy of the notice of intention to investigate to a wide range of organisations representing veterans, service personnel and their dependants. The Authority invited submissions from the Repatriation Commission, the Military Rehabilitation and Compensation Commission, organisations and persons referred to in section 196E of the VEA, and any person having expertise in the field. No submissions were received for consideration by the Authority in relation to the investigation.

Human Rights

9. This instrument is compatible with the Human Rights and Freedoms recognised or declared in the International Instruments listed in Section 3 of the *Human Rights (Parliamentary Scrutiny) Act 2011.* A Statement of Compatibility with Human Rights follows.

Finalisation of Investigation

10. The determining of this Instrument finalises the investigation in relation to suicide and attempted suicide as advertised in the Government Notices Gazette of 25 June 2024.

Statement of Compatibility with Human Rights

(Prepared in accordance with Part 3 of the Human Rights (Parliamentary Scrutiny) Act 2011)

Instrument No.: Statement of Principles No. 39 of 2025

Kind of Injury, Disease or Death: suicide and attempted suicide

This Legislative Instrument is compatible with the human rights and freedoms recognised or declared in the international instruments listed in section 3 of the *Human Rights* (*Parliamentary Scrutiny*) Act 2011.

Overview of the Legislative Instrument

- 1. This Legislative Instrument is determined pursuant to subsection 196B(2) of the *Veterans' Entitlements Act 1986* (the VEA) for the purposes of the VEA and the *Military Rehabilitation and Compensation Act 2004* (the MRCA). Part XIA of the VEA requires the determination of these instruments outlining the factors connecting particular kinds of injury, disease or death with service such being determined solely on the available sound medical-scientific evidence.
- 2. This Legislative Instrument:-
- facilitates claimants in making, and the Repatriation Commission and the Military Rehabilitation and Compensation Commission in assessing, claims under the VEA and the MRCA respectively, by specifying the circumstances in which medical treatment and compensation can be extended to eligible persons who have suicide and attempted suicide ;
- facilitates the review of such decisions by the Veterans' Review Board and the Administrative Appeals Tribunal;
- outlines the factors which the current sound medical-scientific evidence indicates must as a minimum exist, before it can be said that a reasonable hypothesis has been raised, connecting suicide and attempted suicide with the circumstances of eligible service rendered by a person, as set out in clause 5 of the Explanatory Statement;
- replaces Instrument No. 65 of 2016; and
- reflects developments in the available sound medical-scientific evidence concerning suicide and attempted suicide which have occurred since that earlier instrument was determined.
- 3. The Instrument is assessed as being a technical instrument which improves the medico-scientific quality of outcomes under the VEA and the MRCA.

Human Rights Implications

- 4. This Legislative Instrument does not derogate from any human rights. It promotes the human rights of veterans, current and former Defence Force members as well as other persons such as their dependents, including:
- the right to social security (Art 9, *International Covenant on Economic, Social and Cultural Rights*; Art 26, *Convention on the Rights of the Child* and Art 28, *Convention on the Rights of Persons with Disabilities*) by helping to ensure that the qualifying conditions for the benefit are 'reasonable, proportionate and transparent'¹;
- the right to an adequate standard of living (Art 11, ICESCR; Art 27, CRC and Art 28, CRPD) by facilitating the assessment and determination of social security benefits;
- the right to the enjoyment of the highest attainable standard of physical and mental health (Art 12, ICESCR and Art 25, CRPD), by facilitating the assessment and determination of compensation and benefits in relation to the treatment and rehabilitation of veterans and Defence Force members;
- the rights of persons with disabilities by facilitating the determination of claims relating to treatment and rehabilitation (Art 26, CRPD); and
- ensuring that those rights "will be exercised without discrimination of any kind as to race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status" (Art 2, ICESCR).

Conclusion

This Legislative Instrument is compatible with human rights as it does not derogate from and promotes a number of human rights.
