## 2 Schedule 2025, Part 1, clause 3 (at the end of the table)

Add:

147 Reverse R48 A design consisting of:

- (a) in the foreground, a cartoon representation of a Tasmanian devil joey sitting on its haunches sniffing a *Bulbine bulbosa* (also known as the golden rock lily); and
- (b) in the background, partially obscured by the Tasmanian devil joey, a stylised representation of additional golden rock lilies and a rock; and
- (c) the following:
  - (i) "EW"; and
  - (ii) Arabic numerals for the amount, in dollars or cents, of the denomination of the coin, followed by "DOLLAR", "DOLLARS" or "CENTS" as the case requires.
