### 1 Name of legislative instrument

This is the *ASIC Corporations and Credit (Amendment and Repeal) Instrument 2025/590*.

This instrument is made under

- (a) subsections 601QA(1), 655A(1), 912A(3A), 926A(2) and 951B(1) of the *Corporations Act 2001*; and
- (b) subsections 47(3A) and 109(3) of the *National Consumer Credit Protection Act 2009*.

### 4 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.
