52 Application of amendments

- (1) The amendments of section 5 made by Schedule 1 to the *Primary Industries Levies and Charges Disbursement Amendment (Wool and Goat Fibre) Rules 2025* apply in relation to the spending of amounts, or incurring of expenditure, on or after the commencement of this section.
- (2) The amendments of section 44 made by Schedule 1 to the *Primary Industries Levies and Charges Disbursement Amendment (Wool and Goat Fibre) Rules 2025* apply, in relation to a recipient body, to the following:
 - (a) the determination of an amount under subsection 25(2) of the Act on or after the commencement of this section;
 - (b) an amount provided by the head of the agricultural statistics body under subsection 25(5) of the Act for each financial year relevant to the determination of an amount covered by paragraph (a).
