743	Community Laundries in Remote Aboriginal and Torres Strait Islander Communities	To support the establishment or upgrade, and operation and maintenance, of community laundries in remote Aboriginal and Torres Strait Islander communities.
744	Social and Emotional Wellbeing Flexible Funding Pool	To provide for a flexible funding pool to fund short-term, place-based social and emotional wellbeing and healing supports to Aboriginal and Torres Strait Islander families and communities affected by major trauma events.
745	Social and Emotional Wellbeing Scholarships	To provide support for Aboriginal and Torres Strait Islander undergraduate or postgraduate psychology students, including by providing: (a) scholarships to provide financial support for study, living and transport costs; and (b) funding to coordinating organisations to administer the scholarships and provide study support and pastoral care to scholarship recipients.
746	Healing for Strong Families Program	To deliver healing programs for Aboriginal and Torres Strait Islander people who are impacted by family violence or at risk of engagement with child protection systems.
