## A Bill for an Act to amend the law relating to taxation, and for related purposes

The Parliament of Australia enacts:

#### 1 Short title

This Act may be cited as the *Tax Laws Amendment* (2009 *Measures No. 4*) *Act 2009*.

#### 2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

## 344 Transitional provision—technical and further education institutions
