3 The Parliament of Australia enacts:

4 **1 Short title**

5 This Act may be cited as the *Family Assistance Legislation*
6 *Amendment (Child Care Budget Measures) Act 2010*.

7 **2 Commencement**

8 This Act commences on the day this Act receives the Royal
9 Assent.

Schedule 1—Amendments

4 *A New Tax System (Family Assistance) Act 1999*

5 **1 Subsection 84F(1)**

6 Omit “(1)”.

7 **2 At the end of subsection 84F(1)**

8 Add:

9 ; and (d) for the income year ending on 30 June 2010—\$7,778; and

10 (e) for each of the income years ending on 30 June 2011, 30 June
11 2012, 30 June 2013 and 30 June 2014—\$7,500; and

12 (f) for a later income year—the indexed amount substituted
13 under Schedule 4 on 1 July of that later income year for the
14 child care rebate limit for the previous income year.

15 **3 Subsection 84F(2)**

16 Repeal the subsection.

17 **4 After subclause 3(6) of Schedule 4**

18 Insert:

19 *No indexation of CCR limit on 1 July 2010, 1 July 2011, 1 July*
20 *2012 and 1 July 2013*

21 (6A) The indexation of the CCR limit that occurred on 1 July 2010 has
22 no effect.

23 (6B) The CCR limit is not to be indexed on 1 July 2011, 1 July 2012 and
24 1 July 2013.

25 Note: Indexation of the CCR limit resumes on 1 July 2014.

26 **5 Transitional**

27 For the purposes of working out the indexed amount for the CCR limit
28 on 1 July 2014 under Schedule 4 to the *A New Tax System (Family*
29 *Assistance) Act 1999*, the current figure for the CCR limit immediately
30 before that day is taken to be \$7,500.
