| 1 | 4 Imposition of fees for chargeable matters |

| 2 3 | Subject to section 5, the regulations may prescribe fees for chargeable matters. |
| 4 5 | (2) The fees prescribed by the regulations for chargeable matters are imposed, and are so imposed as taxes. |
| 6 7 | (3) Two or more fees may be prescribed for the same chargeable matter. |
| 8 | 5 Matters relating to amount of fees |
| 9 | (1) The regulations may prescribe a fee for a chargeable matter: |
| 10 11 | (a) by specifying an amount (not exceeding \$10,000) as the fee; |
| 12 | (b) by specifying a method for calculating the amount of the fee. |
| 13 14 15 | Note: The limitation in paragraph (a) applies separately to each fee imposed if more than one fee is prescribed for the same chargeable matter (see subsection 4(3)). |
| 16 17 18 | (2) The fee for a chargeable matter need not bear any relationship to the cost of providing any service that forms part of, or is related to, that matter. |
| 19 20 | (3) The fee, or the sum of the fees, for a chargeable matter must not exceed \$50,000. |
