3 The Parliament of Australia enacts:

4 **1 Short title**

5 This Act may be cited as the *Fair Work Amendment Act 2012*.

6 **2 Commencement**

7 (1) Each provision of this Act specified in column 1 of the table
8 commences, or is taken to have commenced, in accordance with
9 column 2 of the table. Any other statement in column 2 has effect
10 according to its terms.

6 (1) A *generic MySuper product* is a MySuper product that is not a
7 tailored MySuper product or a corporate MySuper product.

8 (2) A *tailored MySuper product* is a MySuper product in relation to
9 which section 29TB of the *Superannuation Industry (Supervision)*
10 *Act 1993* is satisfied.

11 (3) A *corporate MySuper product* is a MySuper product that is offered
12 by a superannuation fund that:

13 (a) is a standard employer-sponsored fund (within the meaning
14 of the *Superannuation Industry (Supervision) Act 1993*); and

15 (b) is not a public offer superannuation fund (within the meaning
16 of that Act); and

17 (c) has:

18 (i) one standard employer-sponsor (within the meaning of
19 that Act); or

20 (ii) 2 or more standard employer-sponsors (within the
21 meaning of that Act) that are associates of each other for
22 the purposes of that Act.

23 (4) A reference in this Act to a superannuation fund doing a thing in
24 relation to a matter (for example, offering a MySuper product or
25 making an application or submission) is a reference to the RSE
26 licensee (within the meaning of the *Superannuation Industry*
27 *(Supervision) Act 1993*) of the fund doing that thing.

28 **10 Section 132 (paragraph relating to Division 4)**

29 After “reviews of modern awards”, insert “(other than in relation to
30 default fund terms of modern awards)”.

13 *Superannuation Guarantee Charge Act 1992* in relation to the
14 employee.

15 **149C Default fund terms**

- 16 (1) A modern award must include a default fund term that complies
17 with section 149D.
- 18 (2) A *default fund term* is a term of a modern award that requires,
19 permits or prohibits an employer covered by the award to make
20 contributions to a superannuation fund for the benefit of an
21 employee (a *default fund employee*) who:
22 (a) is covered by the award; and
23 (b) has no chosen fund (within the meaning of the
24 *Superannuation Guarantee (Administration) Act 1992*).

25 **149D Default fund term must provide for contributions to be made**
26 **to certain funds**

27 *Specified superannuation fund offering generic MySuper product*

- 28 (1) A default fund term of a modern award must require an employer
29 covered by the award to make contributions, for the benefit of a
30 default fund employee, to a superannuation fund that:

- 1 (a) offers a generic MySuper product; and
2 (b) is specified in the default fund term of the award in relation
3 to that product;
4 if:
5 (c) the employer will be liable to pay superannuation guarantee
6 charge under the *Superannuation Guarantee Charge Act*
7 *1992* in relation to the employee if the employer does not
8 make contributions to a superannuation fund for the benefit
9 of the employee; and
10 (d) the employer is not making contributions to a superannuation
11 fund referred to in subsection (2), (3), (4) or (5) for the
12 benefit of the employee.

13 *Defined Benefits Scheme*

- 14 (2) A default fund term of a modern award must permit an employer
15 covered by the award to make contributions, for the benefit of a
16 default fund employee, to a superannuation fund in relation to
17 which a default fund employee is a defined benefit member.

18 *Exempt public sector superannuation scheme*

- 19 (3) A default fund term of a modern award must permit an employer
20 covered by the award to make contributions, for the benefit of a
21 default fund employee, to a superannuation fund that is an exempt
22 public sector superannuation scheme.

23 *State public sector superannuation scheme*

- 24 (4) A default fund term of a modern award must permit an employer
25 covered by the award to make contributions, for the benefit of a
26 default fund employee, to a superannuation fund that:
27 (a) is a public sector superannuation scheme (within the meaning
28 of the *Superannuation Industry (Supervision) Act 1993*); and
29 (b) a law of a State requires the employer to make contributions
30 to for the benefit of the employee.

31 *Transitionally authorised superannuation fund*

- 32 (5) A default fund term of a modern award must permit an employer
33 covered by the award to make contributions, for the benefit of a
34 default fund employee, to a superannuation fund in relation to

1 which a transitional authorisation is in operation under
2 section 156K.

3 **14 Section 155A**

4 Repeal the section.

5 **15 At the end of subsection 156(2)**

6 Add:
7 ; and (c) must not review, or make a determination to vary, a default
8 fund term of a modern award.

19 **156A 4 yearly reviews of default fund terms**

20 *Timing of 4 yearly reviews*

21 (1) The FWC must conduct a 4 yearly review of default fund terms of
22 modern awards starting as soon as practicable after each 4th
23 anniversary of the commencement of this Part.

24 Note: The President may give directions about the conduct of those reviews
25 (see section 582).

26 *Two stages of the 4 yearly reviews*

27 (2) There are 2 stages of the 4 yearly review.

1 (3) In the first stage, the FWC must make the Default Superannuation
2 List for the purposes of the review.

3 Note: For the first stage, the FWC must be constituted by an Expert Panel
4 (see subsections 617(4) and (5)).

5 (4) In the second stage, the FWC:

6 (a) must review the default fund term of each modern award; and

7 (b) must make a determination varying the term in accordance
8 with section 156H; and

9 (c) if section 156J applies—must make a determination varying
10 the term in accordance with that section.

11 Note: For the second stage, the FWC must be constituted by a Full Bench
12 (see subsections 616(2A) and (3A)).

13 **Subdivision B—The first stage of the 4 yearly review**

14 **156B Making the Default Superannuation List**

15 (1) In the 4 yearly review, the FWC must make and publish the
16 *Default Superannuation List*.

17 (2) The Default Superannuation List must specify each generic
18 MySuper product that the FWC has determined under section 156E
19 is to be included on the list.

20 (3) The Default Superannuation List must not specify any other
21 product.

22 **156C Applications to list a MySuper product**

23 (1) Before making the Default Superannuation List, the FWC must
24 publish a notice that invites superannuation funds that offer a
25 generic MySuper product to apply to the FWC to have the product
26 included on the list.

27 (2) The notice must specify the period in which an application may be
28 made.

29 (3) After the notice is published, a superannuation fund that offers a
30 generic MySuper product may make a written application to have
31 the product included on the list.

32 (4) The application must:

- 1 (a) be made in the period specified in the notice; and
2 (b) be accompanied by any fees that are prescribed by the
3 regulations; and
4 (c) provide information relating to the first stage criteria.
- 5 (5) The FWC must publish any application made under subsection (3).
- 6 (6) However, if an application includes information that is claimed by
7 the superannuation fund to be confidential or commercially
8 sensitive, and the FWC is satisfied that the information is
9 confidential or commercially sensitive:
- 10 (a) the FWC may decide not to publish the information; and
11 (b) if it does so, it must instead publish a summary of the
12 information which contains sufficient detail to allow a
13 reasonable understanding of the substance of the information
14 (without disclosing anything that is confidential or
15 commercially sensitive).
- 16 (7) A reference in this Act (other than in this section) in relation to an
17 application made under subsection (3) includes a reference to a
18 summary referred to in paragraph (6)(b).

19 **156D Submissions on applications to list a MySuper product**

- 20 (1) The FWC must ensure that all persons and bodies have a
21 reasonable opportunity to make written submissions to the FWC in
22 relation to an application made under subsection 156C(3).
- 23 (2) If:
- 24 (a) a person or body makes a written submission in relation to an
25 application made under subsection 156C(3); and
26 (b) the person or body has an interest in relation to:
- 27 (i) the superannuation fund that made the application; or
28 (ii) if the person or body refers to another superannuation
29 fund in the submission—that superannuation fund;
- 30 then the person or body must disclose that interest in the
31 submission.
- 32 (3) The FWC must publish any submission that is made.

1 **156E Determining applications to list a MySuper product**

- 2 (1) If an application is made under subsection 156C(3) to have a
3 generic MySuper product included on the Default Superannuation
4 List, the FWC must make a determination about whether to include
5 the product on the list.
- 6 (2) The FWC must not determine that the product is to be included on
7 the list unless, taking into account:
8 (a) the information provided in the application; and
9 (b) the first stage criteria; and
10 (c) any submissions that were made in relation to the application;
11 the FWC is satisfied that including the product on the list would be
12 in the best interest of default fund employees to whom modern
13 awards apply or a particular class of those employees.

14 **156F First stage criteria**

15 The *first stage criteria* are as follows:

- 16 (a) the appropriateness of the MySuper product's long term
17 investment return target and risk profile;
- 18 (b) the superannuation fund's expected ability to deliver on the
19 MySuper product's long term investment return target, given
20 its risk profile;
- 21 (c) the appropriateness of the fees and costs associated with the
22 MySuper product, given:
23 (i) its stated long term investment return target and risk
24 profile; and
25 (ii) the quality and timeliness of services provided;
- 26 (d) the net returns on contributions invested in the MySuper
27 product;
- 28 (e) whether the superannuation fund's governance practices are
29 consistent with meeting the best interests of members of the
30 fund, including whether there are mechanisms in place to
31 deal with conflict of interest;
- 32 (f) the appropriateness of any insurance offered in relation to the
33 MySuper product;
- 34 (g) the quality of advice given to a member of the
35 superannuation fund relating to the member's existing
36 interest in the fund and products offered by the fund;

- 1 (h) the administrative efficiency of the superannuation fund;
2 (i) any other matters the FWC considers relevant.

3 **Subdivision C—Second stage of the 4 yearly review**

4 **156G Review of the default fund term of modern awards**

- 5 (1) As soon as practicable after the Default Superannuation List is
6 made, the FWC must review the default fund term of each modern
7 award.
- 8 (2) The FWC must ensure that the following persons have a reasonable
9 opportunity to make written submissions (including submissions
10 requesting that a particular superannuation fund be specified in the
11 term in relation to a generic MySuper product) to the FWC in
12 relation to the default fund term of the award:
- 13 (a) an employee and employer that are covered by the modern
14 award;
- 15 (b) an organisation that is entitled to represent the industrial
16 interests of one or more employees or employers that are
17 covered by the award;
- 18 (c) if the award includes an outworker term—an organisation
19 that is entitled to represent the industrial interests of one or
20 more outworkers to whom the outworker term relates.
- 21 (3) If:
- 22 (a) a person or body (whether or not a person referred to in
23 subsection (2)) makes a written submission in relation to the
24 default fund term of a modern award; and
- 25 (b) the person or body refers to a particular superannuation fund
26 in the submission; and
- 27 (c) the person or body has an interest in relation to that
28 superannuation fund;
- 29 then the person or body must disclose that interest in the
30 submission.
- 31 (4) The FWC must publish any submission that is made.

32 **156H Default fund term must specify certain superannuation funds**

- 33 (1) After reviewing the default fund term of a modern award, the FWC
34 must make a determination varying the term:
-

- 1 (a) to remove every superannuation fund that is specified in the
2 term in relation to a generic MySuper product; and
3 (b) to specify at least 2, but no more than 10, superannuation
4 funds in relation to generic MySuper products that satisfy the
5 second stage test.

6 Note: See subsection (3) for when the default fund term may specify more
7 than 10 superannuation funds.

- 8 (2) A generic MySuper product satisfies the *second stage test* if:
9 (a) it is on the Default Superannuation List; and
10 (b) the FWC is satisfied that specifying a superannuation fund in
11 relation to the product in the default fund term of the modern
12 award would be in the best interests of the default fund
13 employees to whom the modern award applies, taking into
14 account:
15 (i) any submissions that were made in relation to the
16 default fund term of the award; and
17 (ii) any other matter the FWC considers relevant.
- 18 (3) The default fund term may specify more than 10 superannuation
19 funds in relation to generic MySuper products that satisfy the
20 second stage test if, taking into account the range of occupations of
21 employees covered by the modern award, the FWC is satisfied it is
22 warranted.

23 **156J Variation to comply with section 149D**

24 If, at the time of the 4 yearly review, the default fund term of a
25 modern award does not comply with section 149D, the FWC must
26 make a determination varying the term so that it does.

27 **156K Transitional authorisation for certain superannuation funds**

- 28 (1) The FWC may make a transitional authorisation in relation to a
29 superannuation fund (other than a superannuation fund referred to
30 in subsection 149D(1), (2), (3) or (4)) if, at the time of the 4 yearly
31 review, the FWC is satisfied that it is appropriate to make the
32 authorisation.
- 33 (2) The transitional authorisation comes into operation on the day it is
34 made and ceases to be in operation on the day specified in the
35 authorisation.

1 **156L Publishing documents under this Division**

2 If the FWC is required by this Division to publish a document, the
3 FWC must publish the document on its website or by any other
4 means that the FWC considers appropriate.

5 **19 Paragraph 157(1)(a)**

6 After “wages”, insert “or to vary a default fund term of the award”.

8 Insert:

9 **159A Variation of default fund term of modern award**

- 10 (1) The FWC may make a determination varying the default fund term
11 of a modern award in relation to a superannuation fund specified in
12 the term in relation to a generic MySuper product (the *specified*
13 *product*) in the following circumstances:
- 14 (a) to reflect a change in the name of the fund or the specified
15 product;
 - 16 (b) if the fund has ceased to exist—to omit the name of the fund
17 and the specified product;
 - 18 (c) if the specified product has ceased to exist and no other
19 MySuper product is specified in relation to the fund—to omit
20 the name of the fund and the specified product;
 - 21 (d) if the specified product has ceased to exist and another
22 MySuper product is specified in relation to the fund—to omit
23 the name of the specified product;
 - 24 (e) if the Australian Prudential Regulation Authority gives the
25 FWC notice under subsection 29U(4) of the *Superannuation*
26 *Industry (Supervision) Act 1993* that the fund no longer offers
27 the specified product and no other MySuper product is
28 specified in relation to the fund—to omit the name of the
29 fund and the specified product;
 - 30 (f) if the Australian Prudential Regulation Authority gives the
31 FWC notice under subsection 29U(4) of the *Superannuation*
32 *Industry (Supervision) Act 1993* that the fund no longer offers
33 the specified product and another MySuper product is
34 specified in relation to the fund—to omit the name of the
35 specified product.

- 1 (2) The FWC may make a determination under this section:
2 (a) in any case—on its own initiative; or
3 (b) on application by an employee, employer, organisation or
4 outworker entity covered by the modern award.

12 **1 Definitions**

17 section 575, as in force immediately before the commencement of

- 7 (3) The amendments made by items 15, 18, 19 and 20 of Schedule 1 to
8 the amending Act apply in relation to a modern award that is in
9 operation on or after 1 January 2014, whether or not the award was
10 made before that day.

11 **Part 3—Modern awards (Schedule 3)**

13 **3 Part 1 of Schedule 3 to the amending Act**

6 relation to appointments that are made after the commencement of
7 that Part.

7 **30 Operation of section 7 and subsection 25B(1) of the *Acts***
8 ***Interpretation Act 1901* not limited**

9 This Part and Schedule 9 to the amending Act do not limit the
10 operation of section 7 or subsection 25B(1) of the *Acts*
11 *Interpretation Act 1901*.

14 **31 Part 1 of Schedule 10 to the amending Act**

15 The amendment made by Part 1 of Schedule 10 to the amending

19 **Part 11—Regulations**
20

21 **32 Regulations about application, transitional and saving matters**

22 (1) The regulations may prescribe matters of an application,
23 transitional or saving nature relating to the amendments and
24 repeals made by the amending Act.

25 (2) Without limiting subclause (1), the regulations may:

- 26 (a) provide that Part 9 of this Schedule or Part 4 of Schedule 9 to
27 the amending Act applies with specified modifications; or
28 (b) provide that the Transitional Act applies with specified
29 modifications.

- 1 (3) The provisions referred to in subclause (2) have effect subject to
2 regulations made for the purposes of this clause.
- 3 (4) Despite subsection 12(2) of the *Legislative Instruments Act 2003*:
4 (a) regulations relating to the amendments and repeals made by
5 Schedule 9 to the amending Act; and
6 (b) regulations made for the purposes of subclause (2);
7 may be expressed to take effect from a day before the regulations
8 are registered under that Act.
