### A Bill for an Act to amend the *Private Health Insurance Act 2007*, and for other purposes

The Parliament of Australia enacts:

#### 1 Short title

This Act is the *Private Health Insurance Legislation Amendment* (Age of Dependants) Act 2021.

#### 2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

#### 2 Subsection 22-5(2) (heading)

Omit "Dependent child-only", substitute "Dependent person-only".

3 Subsection 22-5(2)

Omit "\*dependent children", substitute "\*dependent persons".

#### 4 Subsection 22-5(3)

Omit "\*dependent children", substitute "\*dependent persons".

#### 5 Paragraph 22-5(4)(c)

Omit "\*dependent child", substitute "\*dependent person".

#### 6 Subsection 22-15(5) (note 2)

Omit "dependent children", substitute "dependent persons".

#### 7 Paragraph 22-25(1)(b)

Omit "\*dependent child", substitute "\*dependent person".

#### 8 Subsection 22-25(2)

Omit "\*dependent child", substitute "\*dependent person".

#### 9 Paragraph 22-30(1)(b)

Omit "\*dependent child", substitute "\*dependent person".

#### 10 Subsection 63-5(4)

Omit "\*dependent child non-student", substitute "\*dependent non-student or \*dependent person with a disability".

#### 11 Subsection 63-5(4)

After "\*dependent children", insert "or \*dependent students".

#### 12 Subsection 63-5(4)

Omit "dependent child non-student" (last occurring), substitute "dependent non-student or dependent person with a disability".

#### 13 Subsection 63-5(5)

Repeal the subsection.

#### 14 Paragraph 333-20(1)(a)

Omit "or section", substitute ", section or Schedule".

#### 15 Subsection 333-20(1) (table, heading to column headed "Chapter/Part/section")

Repeal the heading, substitute:

#### Chapter/Part/section/Schedule

#### 16 Subsection 333-20(1) (table item 3, column headed "Chapter/Part/section")

Omit "and section 188-1", substitute ", section 188-1 and Schedule 1".

#### 17 Clause 1 of Schedule 1 (definition of adult)

Repeal the definition, substitute:

#### adult:

- (a) when used outside Part 2-3—means a person who is not a \*dependent person; or
- (b) when used in Part 2-3—means a person who is not:
  - (i) a \*dependent child; or
  - (ii) a \*dependent non-student; or
  - (iii) a \*dependent student.

#### 18 Clause 1 of Schedule 1 (definition of dependent child)

Repeal the definition, substitute:

dependent child means a person who:

- (a) is aged under 18; and
- (b) does not have a partner.

# 19 Clause 1 of Schedule 1 (definition of dependent child non-student)

Repeal the definition.

#### 20 Clause 1 of Schedule 1

Insert:

#### dependent non-student means a person who:

- (a) is aged between 18 and 31 (inclusive); and
- (b) is not receiving full-time education at a school, college or university; and
- (c) is a dependent non-student under the \*rules of the private health insurer that insures the person; and
- (d) does not have a partner.

#### dependent person means:

- (a) a \*dependent child; or
- (b) a \*dependent non-student; or
- (c) a \*dependent person with a disability; or
- (d) a \*dependent student.

#### dependent person with a disability means a person:

- (a) who is aged 18 or over; and
- (b) who is:
  - (i) a person with a disability within the meaning of the expression *person with a disability* as defined by the Private Health Insurance (Complying Product) Rules; or
  - (ii) a person with a disability within the meaning of the expression *person with a disability* as defined by the \*rules of the private health insurer that insures the person.

To avoid doubt, a *dependent person with a disability* may have a partner.

*dependent student* means a person who:

- (a) is aged between 18 and 31 (inclusive); and
- (b) is receiving full-time education at a school, college or university; and
- (c) is a dependent student under the \*rules of the private health insurer that insures the person; and
- (d) does not have a partner.

#### 21 Clause 1 of Schedule 1 (definition of holder)

Omit "\*dependent child", substitute "\*dependent person".

#### 22 Application

The amendment of paragraph 22-30(1)(b) of the *Private Health Insurance Act 2007* made by this Schedule applies in relation to the following days:

- (a) 1 April 2021;
- (b) each later day.

#### Private Health Insurance (Prudential Supervision) Act 2015

#### 23 Subsection 4(1) (definition of dependent child)

Repeal the definition.

#### 24 Subsection 4(1)

Insert:

*dependent person* has the same meaning as in the *Private Health Insurance Act* 2007.

#### 25 Subsection 15(4)

Omit "dependent children", substitute "dependent persons".
