Downing-street, 15th July, 1901.

Sir,—With reference to my Circular Despatch of the 26th January last, forwarding copies of my telegram of the 24th January and certain other documents issued in consequence of the death of Her late Majesty the Queen, I have the honour to transmit to you, for the information of your Government, a copy of "The Demise of the Crown Act 1901" (1 Edwd. VII. cap. 5), which has recently passed through Parliament and received the Royal Assent.

- 2. It will be observed that it provides that the holding of any office under the Crown, whether within or without His Majesty's dominions, shall not be affected, nor shall any fresh appointment thereto be rendered necessary by the demise of the Crown.
- 3. I have been advised that a person holding a Dormant Commission to administer the Government of a Colony in the absence of the Governor is the holder of an office within the terms of this Act.

CHAPTER 5.

A.D. 1901.

An Act to amend the Law relating to the Holding of Offices in case of the Demise of the Crown.

[2nd July, 1901.]

BE it enacted by the King's most Excellent Majesty, by and with the advice and consent af the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

of Crown on holding of office.

Effect of demise 1. (1) The holding of any office under the Crown, whether within or without His Majesty's dominions, shall not be affected, nor shall any fresh appointment thereto be rendered necessary, by the demise of the Crown.

> (2) This Act shall take effect as from the last demise of the Crown.

Short title.

2. This Act may be cited as the Demise of the Crown Act 1901.

QUEENSLAND DEFENCE FORCE (LAND).

IS Excellency the Governor-General in and over the Commonwealth of Australia, by and with the advice of the Executive Council thereof, has been pleased to approve of the cancellation of the Orders in Council in regard to the delegation of power to the Military Commandant of Queensland to convene Courts-martial, &c., published respectively in the Commonwealth Gazettes No. 33, of the 1st July, 1901, No. 38, of the 30th July, 1901, and No. 41, of the 16th August, 1901, and the substitution therefor of the following, viz.:—

"Under the provisions of the Queensland Defence Acts 1884 to 1896, power is hereby delegated to the Military Commandant of Queensland to convene and constitute Regimental and District Courts-martial in the Northern, Central, and Southern Military Districts of that State, for the trial of non-commissioned Officers or men of the Land Forces; also to approve, confirm, mitigate, or remit any sentence of any such Courts, such delegation of power to take effect on and from the 1st March, 1901."
