WAR PRECAUTIONS (PRICES) REGULATIONS 1916.

DETERMINATION OF MAXIMUM PRICES.

Melbourne, 5th March, 1919.

I, WALTER MASSY GREENE, acting for the Minister of State for Defence, in pursuance of the War Precautions (Prices) Regulations 1916, and on the recommendation of the Chief Commissioner for Prices, do hereby order as follows:—

ORDER No. 581.

LINSEED OIL.—COMMONWEALTH.

1. This Order may be cited as Prices Order No. 581, and shall come into force on the 6th day of March, 1919.

2. Prices Order No. 576, made on the 17th February, 1918, is hereby amended as follows:—

By eliminating the figures 7s. 6d. and 8s. 6d. wherever appearing in the Schedule thereto and substituting therefor respectively the figures 9s. and 10s.

ORDER No. 582.

BUTTER.—{ SOUTH AUSTRALIA. WESTERN AUSTRALIA.

1. This Order may be cited as Prices Order No. 582, and shall come into force on the 7th day of March, 1919.

2. So much of Prices Order No. 517, made on the 28th November, 1918, as relates to South Australia, and Prices Order No. 531, made on the 11th December, 1918, are hereby repealed.

3. This Order shall apply to all the proclaimed areas in the States of South Australia and Western Australia specified in the Schedule to this Order.

4. The maximum price which may be charged for Butter shall, until further order, be as set out in the Schedule to this Order.
