KNOW you that confiding in your loyalty, integrity and ability, I, William John McKell, the Governor-General in and over the Commonwealth of Australia, acting with the advice of the Federal Executive Council, in pursuance of the *Commonwealth Conciliation and Arbitration Act 1904-1946*, do hereby appoint you to be a Chief Judge of the Commonwealth Court of Conciliation and Arbitration as on and from

the seventeenth day of June, in the year One thousand nine hundred and forty-seven: To have, hold, exercise and enjoy the said office subject to the said Act.

Given under my hand and the Great Seal of the Commonwealth of Australia this thirteenth day of June, in the year of our Lord One thousand nine hundred and forty-seven, and in the eleventh year of His Majesty's reign.
