## PROCLAMATION

Commonwealth of Australia to wit.  
W. J. SLIM  
Governor-General.

By His Excellency the Governor-General in and over the Commonwealth of Australia.

WHEREAS it is provided by sub-section (2.) of section two of the *Navigation Act 1952* that certain sections of that Act (including section thirty) shall come into operation on such dates as are respectively fixed by Proclamation:

Now therefore I, Sir William Joseph Slim, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, hereby fix the fifth day of June, One thousand nine hundred and fifty-three as the date on which section thirty of the *Navigation Act 1952* shall come into operation.

Given under my hand and the Seal of the Commonwealth this fifth day of June, One thousand nine hundred and fifty-three and in the second year of Her Majesty's reign.

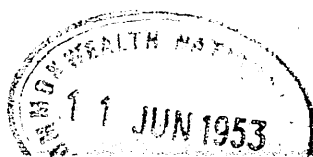
