PROCLAMATION

Commonwealth of
Australia to wit
PAUL HASLUCK
Governor-General.

By His Excellency the Governor-General
in and over the Commonwealth of
Australia.

WHEREAS it is provided by section 2 of the Public Works Committee Act 1969 that that Act shall come into operation on a date to be fixed by Proclamation.

NOW THEREFORE I, Sir Paul Meernaa Caedwalla Hasluck, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, fix the twenty-fourth day of November, One thousand nine hundred and sixty-nine, as the date on which that Act shall come into operation.

GIVEN under my Hand and the Great Seal of the Commonwealth this nineteenth day of November in the year of (L.S.) Our Lord One thousand nine hundred and sixty-nine, and in the eighteenth year of Her Majesty's reign.

QUARANTINE PROCLAMATION No. 82A

Commonwealth of
Australia to wit
PAUL HASLUCK
Governor-General.

By His Excellency the Governor-General
in and over the Commonwealth of
Australia.

WHEREAS by sub-section (1.) of section 13 of the Quarantine Act 1908-1969 it is enacted, amongst other things, that the Governor-General may, by proclamation, prohibit the importation into Australia of any animals or plants or any parts of animals or plants:

AND WHEREAS by sub-section (2.) of that section it is enacted that the power of prohibition under that section shall extend to authorize the prohibition generally or with limitations as to place and subject-matter, and either absolutely or subject to any specified conditions or restrictions:

AND WHEREAS by Quarantine Proclamation No. 76A published in the Gazette on the twenty-eighth day of July, One thousand nine hundred and sixty-six, the importation into Australia of certain animals (including dogs and cats) was prohibited unless certain conditions were complied with and with limitations as to place and subject to certain conditions and restrictions:

AND WHEREAS by Quarantine Proclamation No. 81A published in the Gazette on the tenth day of February, One thousand nine hundred and sixty-nine, Quarantine Proclamation No. 76A was revoked in so far as it prohibited the importation of bovine animals, and other provision was made in its stead with respect to the importation of cattle:

AND WHEREAS it is desirable to revoke Quarantine Proclamation No. 76A in so far as it prohibits the importation of dogs and cats, and make other provision in its stead:

NOW THEREFORE I, Sir Paul Meernaa Caedwalla Hasluck, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, hereby—

- (a) revoke Quarantine Proclamation No. 76A in so far as it prohibits the importation into Australia of dogs and cats;
- (b) prohibit the importation into Australia of a dog or cat from a country other than the United Kingdom of Great Britain and Northern Ireland, the Channel Islands, Ireland or New Zealand unless the Minister, being satisfied that the dog or cat is being imported for scientific purposes or in other special circumstances, has, by instrument in writing, consented to the importation of the dog or cat and that instrument is produced to the Collector of Customs;
- (c) prohibit the importation into Australia of a dog or cat, from the United Kingdom of Great Britain and Northern Ireland, the Channel Islands or Ireland unless the Director of Quarantine has, by instrument in writing, consented to the importation of the dog or cat and that instrument is produced to the Collector of Customs;
- (d) prohibit the importation into Australia of a dog or cat from the United Kingdom of Great Britain and Northern Ireland, the Channel Islands or Ireland on a vessel used in navigation by air;
- (e) prohibit the importation into Australia of a dog or cat from the United Kingdom of Great Britain and Northern Ireland, the Channel Islands or Ireland—
 - (i) in the case of the importation of a dog or cat from the United Kingdom of Great Britain and Northern Ireland—unless the dog or cat is shipped to Australia at one of the following ports in that country, that is to say, London, Southampton, Liverpool, Hull, Newport, Glasgow, Immingham, Birkenhead, Bristol, Avonmouth, Cardiff, Swansea, Newcastle and Belfast;
 - (ii) in the case of a dog or cat that is imported from the Channel Islands—unless the dog or cat is shipped to Australia at one of the ports specified in the last preceding sub-paragraph other than the port of Belfast; and
 - (iii) in the case of a dog or cat that is imported from Ireland—unless the dog or cat is shipped to Australia from one of the following ports in that country, that is to say, Dublin and Cork;

- (f) prohibit the importation into Australia of a dog or cat from New Zealand on a vessel used in navigation by air—
 - (i) unless the dog or cat is so confined on the vessel in a cage or box that it is kept separate from any animal on the vessel other than another dog or cat, as the case may be; and
 - (ii) unless no animals are being carried on the vessel the importation of which into Australia on a vessel used in navigation by air is prohibited under the Quarantine Act 1908-1969; and
- (g) prohibit the importation into Australia of a dog or cat from New Zealand on a vessel used in navigation by sea—
 - (i) unless the vessel is a vessel that trades exclusively between Australia and New Zealand; or

(ii) unless no animals, other than animals of Australian or New Zealand origin, have been carried on the vessel during the voyage in the course of which the dog or cat is carried to Australia and the Director of Quarantine or an officer authorized by him has, by instrument in writing, consented to the dog or cat being carried to Australia on that vessel and the instrument is produced to the Collector of Customs.
