GENERAL INFORMATION

This Gazette publishes details of ballot allocations made in accordance with the allocation arrangements set down in Australian Customs Notice 88/220 published on 21 November 1988.

The Gazette contains a Table in Part 1 specifying details of quota categories relevant to quota entitlements outlined in Part 2.

Part 3 lists statistical data for each category.

Explanatory Key for Table:-

QUOTA PERIOD - e.g. 8903G2 - 89=last 2 digits of the calendar year viz. 1989.
03=indicates the calendar month the quota period commenced.
G2=scheme code, indicating type of quota and the number of allocations in any quota period viz. ballot allocation .

PART 1

NOTICE OF MAKING A DETERMINATION UNDER PART XVI OF THE CUSTOMS ACT 1901

In pursuance of Section 273B of the Customs Act 1901, notice is hereby given that Determination Number LB903G2001 was made in relation to a subitem in Schedule 5 to the Customs Tariff Act 1987, set out in Column 1 of the Table hereunder, and that, subject to any conditions set out hereunder, that Determination applies to goods that are:

- (1) specified in Column 3 of that Table hereunder, corresponding to that subitem set out in Column 1;
- (2) classified under a subheading of Schedule 3 to the Customs Tariff Act 1987, specified in the item of Schedule 5 to the Customs Tariff Act 1987 set out in Column 2 of that Table hereunder, opposite that subitem set out in Column 1;
- (3) entered for home consumption not earlier than 1 March 1989 and not later than 28 February 1990 by the person specified in that Determination, as shown in Part 2; and
- (4) in total, not in excess of such quantity or such value as is specified in that Determination, as shown in Part 2.
