



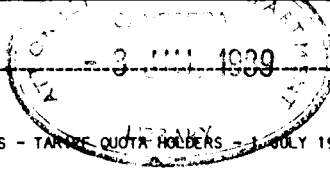

GENERAL INFORMATION

Explanatory Key for Table:-

QUOTA PERIOD - e.g. 8907A1 - 89=last 2 digits of the calendar year viz. 1989.
07=indicates the calendar month the quota period commenced.
A1=scheme code, indicating type of quota and the number of allocations in any quota period viz. cheese, first allocation.

UQ (Unit of Quantity) - KG=Kilogram.

PART 1

NOTICE OF MAKING A DETERMINATION UNDER PART XVI OF THE CUSTOMS ACT 1901

In pursuance of Section 273B of the Customs Act 1901, notice is hereby given that Determination Number LB907A1001 was made in relation to a subitem in Schedule 5 to the Customs Tariff Act 1987, set out in Column 1 of the Table hereunder, and that, subject to any conditions set out hereunder, that Determination applies to goods that are:

- (1) specified in Column 3 of that Table hereunder, corresponding to that subitem set out in Column 1;
- (2) classified under a subheading of Schedule 3 to the Customs Tariff Act 1987, specified in the item of Schedule 5 to the Customs Tariff Act 1987 set out in Column 2 of that Table hereunder, opposite that subitem set out in Column 1;
- (3) entered for home consumption not earlier than 1 July 1989 and not later than 30 June 1990 by the person specified in that Determination, as shown in Part 2; and
- (4) in total, not in excess of such quantity or such value as is specified in that Determination, as shown in Part 2.
