ELIGIBILITY

Only persons accepted by the Authority as being affected by a particular decision may be supplied a statement of reason or a reconsideration of the decision.

CONTENT OF REQUEST

- full name
- address and phone number at which the person making the request can be contacted
- nature of the request
- reasons for making the request
- how the decision affects you

TIME LIMIT

If a person is dissatisfied with the decision, they may, within 21 days on which the notice of decision is published in the Gazette request the Authority to reconsider the decision. They shall set out in the request the reasons for making the request. The Authority shall, within 40 days after the day on which it receives the request, reconsider the decision. The Authority shall give to the person who has requested the reconsideration of the decision notice in writing of the outcome. If the person is dissatisfied with that decision, an application may be made to the Administrative Appeals Tribunal for review of the decision by the Authority.
