



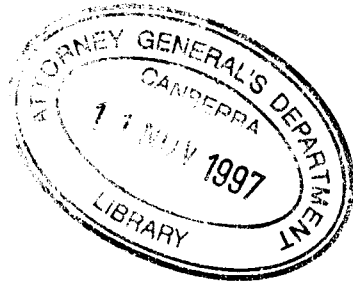

## REVIEW PROCEDURES & RIGHTS

IF YOU ARE A PERSON AFFECTED BY A DECISION NOTIFIED HEREIN  
YOUR ATTENTION IS DRAWN TO THE FOLLOWING REVIEW PROCEDURES & RIGHTS AVAILABLE TO YOU IN RESPECT OF THESE DECISIONS  
OF THE AUTHORITY

1. You have a statutory right to obtain a written statement setting out the reasons for the Authority's decision (if one has not already been supplied).
2. The Authority will undertake an internal review of the decision only where you have made an application in accordance with point 4 below.
3. The person who reviews this decision may uphold or change the initial decision and that initial decision is taken for all purposes not to have been made.
4. An application for review must be made in writing and must comply with the following:
  - (In the case of a decision to suspend, revoke, reinstate, grant or refuse a permit) Applications must be made within 21 days of the date of publication of details of the decision in the Commonwealth Gazette;
  - (In the case of a decision to impose a Permit Application Assessment Fee) Application must be made within 21 days of the date specified in the notice advising of the imposition of a Permit Application Assessment Fee - the Permit Application Assessment Fee must still be paid within the prescribed time or the application will lapse;
  - (In all cases) Application must be accompanied by a written statement of your reasons for making the request for review (including information concerning why you are a person affected by the decision).
5. Internal reviews of decision are carried out by a more senior delegate (and in the case where the Chairperson has made the initial decision - the Marine Park Authority). A review of the initial decision must be made by the Authority within 40 days of receipt of your request.
6. No fee is payable for an application to review a decision of the Authority referred to in this notice. (Note however that Permit Application Assessment Fees must still be paid within the prescribed time, even though you may have appealed the imposition or level of the fee, or the application will lapse)
7. You have the right to apply under the *Freedom of Information Act 1982* for access to documents relating to the Authority's decision. Applications for access to documents under FOI must be accompanied by a \$30 application fee and specify the documents sought. Further charges may be imposed for search, retrieval, copying, decision making time and postage.
8. Application to the Administrative Appeal Tribunal may only be made in respect of a decision which has already undergone internal review.
