The conditions under which the Supplies will be indented are as follow, viz.:—

A. W. SMART,

1. Where samples are provided for, the supplies are to be equal in quality and colour to the indent sample, but as to weight and otherwise are to conform to the specification. In cases where supplies of a particular maker or of a particular brand or trade mark or of a particular distinguishing mark of such maker, brand, or trade mark are required, the supplies shall conform in all respects with the specified requirements.

2. The supplies must be delivered as directed by the Government Printer, Melbourne, either at the Government Printing Office or at a store situate in the city of Melbourne, but delivery will not be deemed to have been made until the supplies have been approved of.

3. If on inspection the supplies be considered inferior in quality or manufacture to the indent sample, or not in conformity with the specification, the Government Printer will have power to reject it. In the event of such rejection, or of the paper or envelopes not being delivered at the time specified in the schedule, he will purchase elsewhere such paper or envelopes as may be suitable, and charge the indentor with the excess of price paid over the indent price.

4. In cases of rejection the supplies must be removed by the indentor within forty-eight hours after notice of such rejection has been given him, and if not so removed the Government Printer is hereby empowered to send such supplies to any store in Melbourne, to be there stored at the indentor's risk and expense.

5. Indentors are not at liberty to transfer their indents under cover of power of attorney, coupled with an interest or otherwise.

6. In the event of the indentor failing to carry out the indent satisfactorily, the indent security money will be absolutely forfeited.

7. The packages, cases, &c., will become the property of the

Government without extra charge.

8. The successful tenderer must sign the indent agreement within three days of the acceptance of tender, and furnish security in the sum or sums indicated. In the event of the indent not being signed or the security not being deposited with the Government Printer within three days of acceptance of tender, fresh tenders will be invited or another offer accepted.
