IMPORTATION OF CARBIDE OF CALCIUM.

PROCLAMATION

Australia to wit. FORSTER, Governor-General. By His Excellency the Governor-General of the Commonwealth of Australia.

W HEREAS by the Customs Act 1901-1920 it is enacted that all goods the importation of which may be prohibited by Proclamation are prohibited imports:

And whereas it is desirable to prohibit the importation of carbide of calcium into the Commonwealth of Australia unless the consent in writing of the Minister of State for Trade and Customs has first been obtained:

Now therefore I, Henry William, Baron Forster, Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby prohibit the importation of carbide of calcium into the Commonwealth of Australia unless the consent in writing of the Minister of State for Trade and Customs has first been obtained.

This Proclamation may be cited as Customs Proclamation No. 18. (T. & C. 20/C.9634.)

REVOCATION OF PROCLAMATION RELATING TO THE EXPORTATION OF GOODS TO GERMANY, AUSTRIA-HUNGARY, TURKEY, AND BULGARIA.

PROCLAMATION

Australia to wit. FORSTER, Governor-General. By His Excellency the Governor-General of the Commonwealth of Australia.

W HEREAS by the Customs Act 1901-1920 it is among other things enacted that the Governor-General may, by Proclamation, prohibit the exportation of any goods the exportation of which would, in his opinion, be harmful to the Commonwealth, and that the power above-mentioned extends to authorize the prohibition of the exportation of goods generally, or to any specified place, and either absolutely or so as to allow of the exportation of the goods subject to any condition or restriction:

And whereas by a Proclamation issued on the fourteenth day of January, 1920, and published in the Commonwealth Gazette of the fourteenth day of January, 1920, the exportation of goods to Germany, Austria-Hungary, Turkey, and Bulgaria was prohibited unless the consent in writing of the Minister of State for Trade and Customs to such exportation had first been obtained:

And whereas it is desirable to revoke the said Proclamation:

Now therefore I, Henry William, Baron Forster, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby revoke the said Proclamation.

This Proclamation may be cited as Customs Proclamation No. 19.
