

The minimum remuneration payable to an adult (male) in the Commonwealth Public Service is £174 per annum.

#### NOTIFICATION OF VACANCIES

A PPLICATIONS will be received from persons qualified for appointment to the positions specified below.

Applicants outside the Public Service are eligible for appointment to the Administrative and Professional Divisions, but are not eligible for appointment to Clerical or General Division vacancies, unless they were in the service of a State on 1st January, 1901, or are at present permanent officers in the service of a State, or have retired from the service of the Commonwealth or of a State.

Applications must be in the applicant's handwriting, should show fully qualifications for the position sought, and must, to insure consideration, be forwarded to the Public Service Inspector in the State in which the vacancy exists in time to reach the office of the Public Service Inspector not later than the date shown in each case.

In the case of officers of the Commonwealth Public Service applications should be forwarded through the Department to which the officer is attached.

In the case of applicants who are officers of the Public Service of the Commonwealth or of a State the following particulars should be set out at the foot of the application:—

Designation Office or Branch
Age last birthday (in years)
Length of service (in years)
Salary (per annum)
Date of receipt of present salary

Applicants from outside the Service should state full name and date and year of birth. Copies only of diplomas, references, testimonials, or certificates should be forwarded. If the originals are required they will be asked for.

Minimum and maximum salaries where shown indicate the Milliam and maximum sataries where snown indicate the limits of the class or grade in which the position is classified. Subject to the provisions of the Public Service Act appointments may be made at any salary within those limits. Cost of living allowances are subject to review by the Arbitration Court from time to time. Successful appointees must comply with the life assurance provisions of the Public Service Act and Regulations. Regulations.

Officers of the Public Service should note that in any case where the minimum salary of a position in the Clerical Division is not the minimum salary of a Class, and the successful applicant is not eligible for the former by reason of not having received the salary of the next lower subdivision for twelve months, he will be granted an allowance equal to the difference between the salary for which he is eligible and the minimum salary of the position until he can be advanced by annual subdivisional increments to the latter salary.

If the officer appointed to any such position is eligible to become, but is not, a member of the organization which obtained the award, he can only be paid the rates of salary prescribed in the Public Service Act or Regulations for the position to which he has been appointed, unless and until he becomes a member of the organization, when the award rates shall apply.

Officers promoted to positions in the Fourth Class, which come within the scope of the award of the Australian Commonwealth Public Service Clerical Association, may be retained at the salary of £245 where, in the opinion of the Acting Commissioner, the fixing of that salary as a maximum is justified.

Officers who may be transferred without promotion or increase of salary, as the result of an application for an advertised vacancy, will be required to pay their own expenses of removal unless the transfer comes within the conditions passeribed in Public Service Regulation No. 54.
