THE TERRITORY FOR THE SEAT OF GOVERNMENT.

The Stock Ordinance 1920-1921,

W HEREAS by section 83 of the Stock Ordinance 1920-1921 it is provided that the Minister, by notice published in the Commonwealth Gazette, may declare that any disease therein mentioned, not being scab in sheep, shall be a disease to which the provisions of Part V. of the said Ordinance mentioned or set out in the notice shall on the day period therein tioned or set out in the notice shall, on the day named therein. apply, and thereupon, on the said day, the said provisions shall apply to that disease, and for that purpose the meaning of the word "diseased" shall be extended so as to apply to stock having any such disease:

Now therefore I, Alexander Poynton, the Minister of State for Home and Territories, do hereby declare the following diseases to be diseases to which the provisions of Part V. of the Stock Ordinance 1920-1921 shall, on and after the date of the publication of this notice in the Commonwealth Gazette, apply:—

- (1) The diseases in stock known as "Actinomycosis,"
 "Cancer," "Manifest Tuberculosis," "Blackleg"
 (known also as "Quarterill" and "Symptomatic
 Anthrax"), and "Anthrax," or "Cumberland Disease";
- (2) The disease in cattle known as "Pleuro," or "Pleuropneumonia bovum contagiosa";
- (3) The disease in pigs known as "Swine Fever," "Hog Cholera," or "Contagious Pneumo Enteritis.",

Rabbit Destruction Ordinance 1919.

Notice under section 33 of the above-mentioned Ordinance to owners or occupiers within the Territory for the Seat of Government of the Commonwealth of Australia.

In pursuance of the provisions of section 33 of Ordinance. No. 6 of 1919, notice is hereby given by the Minister that the owners or occupiers of all or any lands within the abovementioned Territory shall, on or before the 14th day of April, One thousand nine hundred and twenty-one, respectively commence the work of suppressing and destroying fabbits and noxious animals upon such lands and upon any roads bounding or intersecting the same. The period during which the said work shall be continued and systematically carried out shall be from 14th April, 1921, to 31st December, 1921. The means which shall be adopted for carrying out the said work shall be poison, digging out, or trapping, being means which have been previously sanctioned under the said Act.




