THE NORTHERN TERRITORY OF AUSTRALIA.

REGULATIONS UNDER THE CROWN LANDS ORDINANCE
1912-1918.

I THE GOVERNOR-GENERAL in and over the Commonwealth of Australia, acting with the advice of the Federal Executive Council, pursuant to section 55 of the *Crown Lands Ordinance* 1912-1918, hereby make the following Regulation:—

Regulation 1 of the regulations under the *Crown Lands Ordinance* 1912-1918 is repealed and the following regulation inserted in its stead:—

"1.—(1) (a) When any lands have been gazetted as available for leasing, applications for leases (other than miscellaneous leases) under the Ordinance may be sent to the Lands Office at Darwin, or to the Department of Home and Territories in Melbourne, at any time within the time specified in the *Gazette* for the receipt of applications. Application for Leases.

(b) Any land gazetted as available for leasing and not allotted by the Classification Board shall remain open for lease, unless withdrawn or re-advertised by subsequent notice in the *Gazette* setting out any altered conditions of occupancy.

(c) Applications lodged after the time specified in the *Gazette* notice shall have priority according to the date of their receipt in the Lands Office at Darwin or the Department of Home and Territories in Melbourne.

(2) Applications for Miscellaneous Leases may be made at any time whether the land has been gazetted as available for leasing or not, but must be sent to the Lands Office at Darwin.

(3) Each application for a Pastoral Lease or Agricultural Lease shall be verified by a Statutory Declaration in accordance with the *Statutory Declarations Act 1911*.

(4) The term of any lease shall commence on the quarter-day next following the date of the allotment of the lease by the Classification Board or the purchase of the lease at auction.

(5) The quarter-days for the purpose of this regulation shall be the first days of January, April, July and October respectively.

AN ORDINANCE

To annul the Notice fixing the day of commencement of the Workmen's Compensation Ordinance 1920.

BE it ordained by the Governor-General of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *Northern Territory Acceptance Act 1910-19* and the *Northern Territory (Administration) Act 1910*, as follows :—

Short title.

1. This Ordinance may be cited as the *Workmen's Compensation Ordinance 1921*.

Annulment of notice of commencement of Workmen's Compensation Ordinance 1920.

2.—(1.) The notice issued prior to the commencement of this Ordinance in pursuance of section two of the *Workmen's Compensation Ordinance 1920*, whereby the day for the commencement of that Ordinance is fixed is hereby annulled and that Ordinance shall not be deemed to have commenced on the day fixed in that notice.

(2.) The issue of the notice annulled by this section shall not affect the power to fix, in pursuance of section two of the *Workmen's Compensation Ordinance 1920*, the day upon which that Ordinance shall commence.

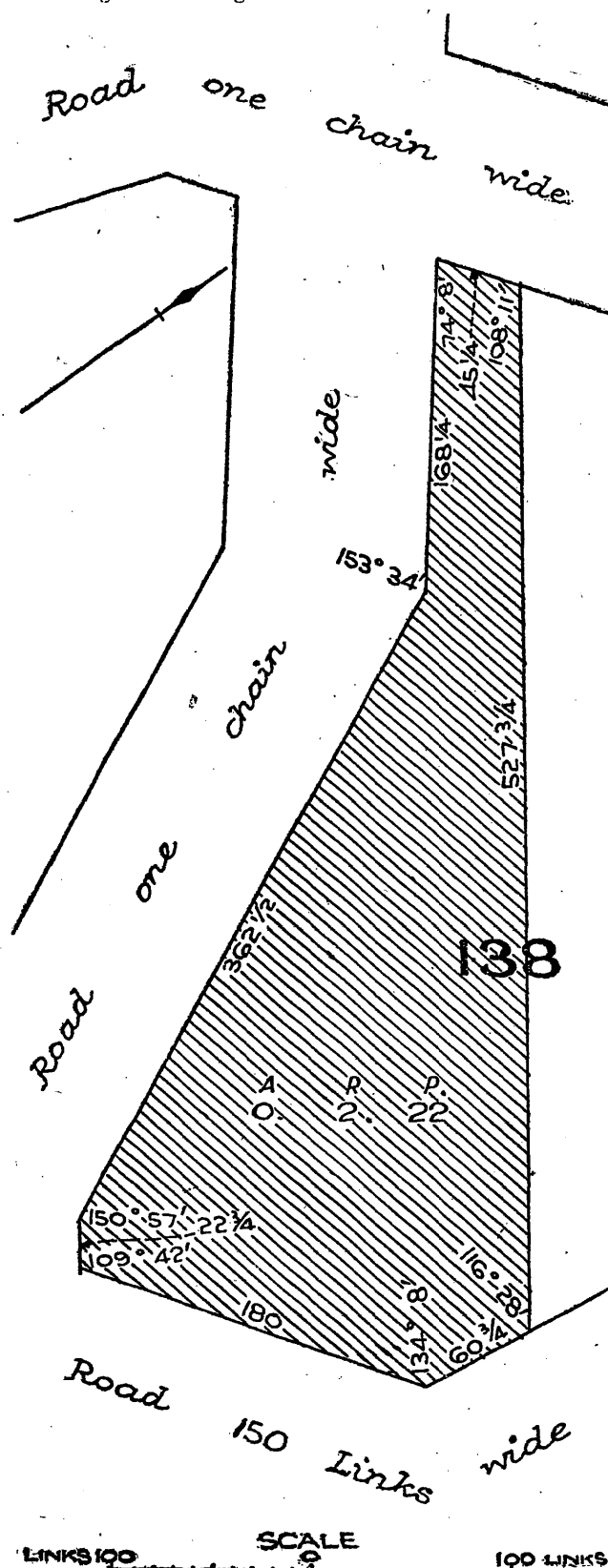

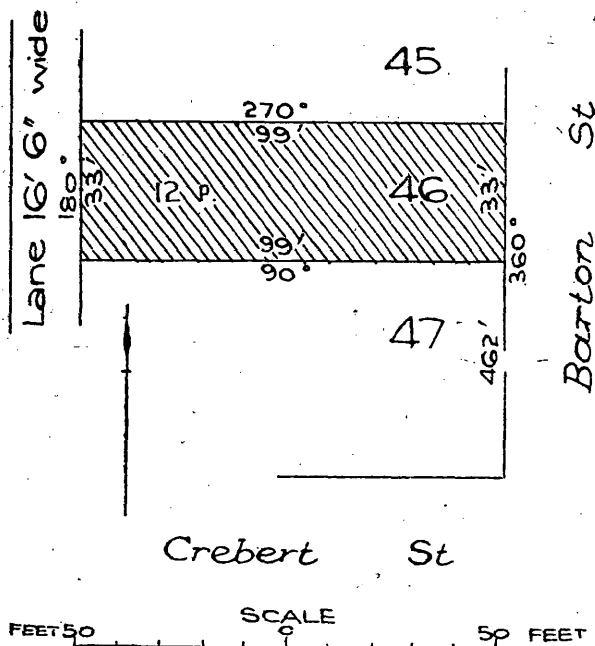

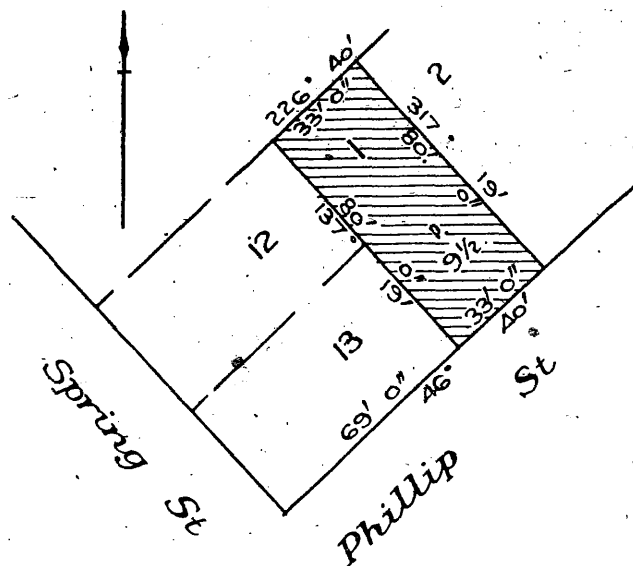

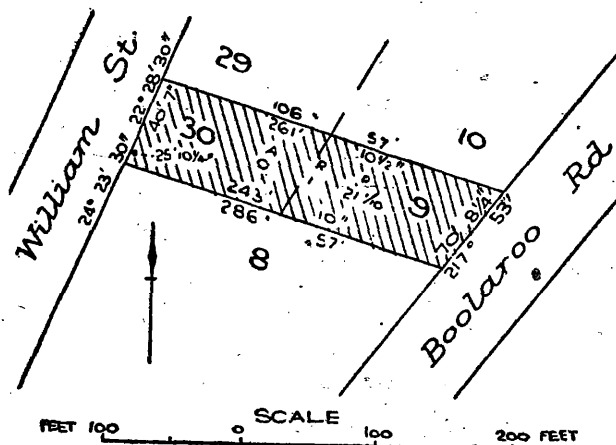
