WHEREAS by the *Invalid and Old-age Pensions Act* 1908-1920 it is enacted that a benevolent asylum or hospital means any benevolent asylum or hospital which is wholly or partly maintained by contributions from the Consolidated Revenue Fund of the Commonwealth or the Consolidated Revenue of a State, and which is proclaimed by the Governor-General to be a benevolent asylum or a hospital for the purposes of the above-mentioned Act: Now therefore I, Henry William, Baron Forster, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby proclaim the following benevolent asylum and hospital, which are wholly or partly maintained by contributions from the Consolidated Revenue of the States specified, to be a benevolent asylum and a hospital for the purposes of the *Invalid and Old-age Pensions Act* 1908-1920:—

### STATE OF WESTERN AUSTRALIA.

*Benevolent Asylum.*—Women's Home, Fremantle.

### STATE OF TASMANIA.

WHEREAS by the *Invalid and Old-age Pensions Act* 1902-1918 it is enacted that the Governor-General may proclaim benevolent asylums or hospitals which are wholly or partly maintained by contributions from the Consolidated Revenue Fund of the Commonwealth or the Consolidated Revenue of a State to be benevolent asylums or hospitals for the purposes of the above-named Act:

And whereas by a Proclamation issued on the 9th day of February, 1916, the Old Men's Home, Fremantle, and the Old Women's Home, Perth, in the State of Western Australia, were proclaimed benevolent asylums for the purposes of the *Invalid and Old-age Pensions Act* 1908-1920: And whereas it is desirable to revoke the said Proclamation: Now therefore I, Henry William, Baron Forster, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby revoke the said Proclamation in so far as it relates to the Old Men's Home, Fremantle, and the Old Women's Home, Perth.

## AN ORDINANCE

To repeal the Lands Ordinance 1919.

**B**E it ordained by the Governor-General of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *New Guinea Act 1920*, as follows:—

Short title.

1. This Ordinance may be cited as the *Lands Ordinance Repeal Ordinance 1921*.

Repeal.

The *Lands Ordinance 1919* is hereby repealed:

Saving.

Provided that such repeal shall not affect the validity of anything done in pursuance of the said Ordinance prior to the commencement of this Ordinance.
