# PROCLAMATION

Australia to wit. Forster, Governor-General. By His Excellency the Governor-General of the Commonwealth of Australia.

W HEREAS by the Customs Act 1901-1920 it is amongst other things enacted that the Governor-General may, by Proclamation, prohibit the exportation of any goods the exportation of which would, in his opinion, be harmful to the Commonwealth, and that the power abovementioned extends to authorize the prohibition of the exportation of goods generally, or to any specified place, and either absolutely or so as to allow of the exportation of the goods subject to any condition or restriction.

And whereas by a Proclamation issued on the second day of July, 1919, and published in the Commonwealth Gazette of the third day of July, 1919, the exportation of all goods from the Commonwealth to (late) German New Guinea was prohibited unless the consent in writing of the Minister of State for Trade and Customs had first been obtained:

And whereas it is desirable to revoke the said Proclamation:

Now therefore I, Henry William, Baron Forster, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby revoke the said Proclamation:

This Proclamation is in lieu of Customs Proclamation No. 46, issued on the sixteenth day of November, 1921, and published in the *Commonwealth Gazette* of the seventeenth day of November, 1921.

This Proclamation may be cited as Customs Proclamation No. 50.—(T. & C. 21/E.4719.)

ORDER UNDER SECTION 7.

EXEMPTION OF TRADE WITH NAURU.

Commonwealth of Australia to wit. FORSTER, Governor-General.

By His Excellency the Governor-General of the Commonwealth of Australia.

W HEREAS by section 7 of the Navigation Act 1912-1920 it is among other things enacted that the Governor-General may by Order declare that the carrying of passengers or cargo between ports in any Territory under the authority of the Commonwealth, or between ports in any such Territory and any other Australian ports, or ports in any other such Territory, shall not be deemed engaging in the coasting trade:

And whereas it is desirable that the carrying of passengers and cargo between Nauru, a Territory under the authority of the Commonwealth, and ports in Australia, or ports in any other such Territory, shall not, during the period during which this Order is in torce, be deemed engaging in the coasting trade:

Now therefore I, Henry William, Baron Forster, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby declare that the carrying of passengers and cargo between Nauru and ports in Australia, or ports in any other Territory under the authority of the Commonwealth, shall not, during the period during which this Order is in force, be deemed engaging in the coasting trade:

And I do further declare that this Order shall come into operation on the first day of January, One thousand nine hundred and twenty-two, and shall remain in force until the thirty-first day of December, One thousand nine hundred and twenty-two.

# THE NORTHERN TERRITORY OF AUSTRALIA.

No. 16 of 1921.

# AN ORDINANCE

To amend "The Food and Drugs Act, 1908" of the State of South Australia in its application to the Northern Territory, and for other purposes.

BE it ordained by the Governor-General of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Northern Territory Acceptance Act 1910-1919 and the Northern Territory (Administration) Act 1910 as follows:—

Short title.

1. This Ordinance may be cited as the Food and Drugs Ordinance 221.

Dilution of spirits. Amendment of Act 968 of 1908, sec. 22. S.A. No. 1252,

- 2. Section twenty-two of *The Food and Drugs Act* 1908 of the State of South Australia, in its application to the Northern Territory, is amended by omitting paragraph (5) of the proviso thereto and inserting in its stead the following paragraph:—
  - "(5.) Where spirits are not adulterated otherwise than by being diluted with water, and such dilution, being estimated by Sykes' hydrometer has not reduced the spirits more than thirty-five degrees under proof for brandy, whisky, rum, schnapps, unsweetened gin, or other unsweetened spirits, or forty-five degrees under proof for sweetened gin or other sweetened spirits."

Dealing in absinthe prohibited

- 3.—(1.) Any person who sells, or in any manner disposes of, delivers, or supplies, to any other person, or deals or trafficks in, or has in his possession, order, or disposition, any of the liquor known as "absinthe," shall be liable to a penalty for a first offence of not more than Twenty pounds, and for a second or any subsequent offence of not more than Fifty pounds.
- (2.) In this section, without restricting the meaning of the word "possession", absinthe shall be deemed to be in the possession of any person so long as it remains or is upon any land or premises occupied by him, or is enjoyed or controlled by him in any place whatever, unless it is shown that he had no knowledge thereof.

For first ounce, 4d.; for each additional ounce or fraction thereof. 2d.

Post Cards

Single, 2d. each; with reply paid, 2d. each half.

Commercial Papers—
For every 2 ozs. or fraction thereof, 1½d., with a minimum of 4d.

Printed Papers—
For every 2 ozs. or fraction thereof, 1½d.

Patterns, Samples, and Merchandise

For every 2 ozs. or fraction thereof, 1½d., with minimum of 3d.

Articles Impressed for the Use of the Blind— For each 20 ozs. or fraction thereof, 1d.

Commercial Papers-For every 2 ozs., 12d., with minimum of 3d.

Industrial Peace Acts 1920 (Commonwealth).

ENGINEERS' (COAL INDUSTRY) SPECIAL TRIBUNAL.

#### AWARD.

IN the matter of the Industrial Peace Acts 1920, and in the matter of the Industrial Dispute between the Amalgamated Society of Engineers (Organization of Employees) and the Abermain Colliery Company, Limited, and Others.

- I, Charles Hibble, Chairman of the Engineers' (Coal Industry) Special Tribunal for and on behalf of the said Tribunal, do hereby order, award and direct that, as the cost of living has decreased in the Commonwealth of Australia, and as the members of the Claimant Organization, along with other classes of labour of the respondents, received an increase on and from 27th September, 1920, in their rates of wages, and, as I am of opinion that the industry must be carried on as a whole in regard to any alterations of hours, wages and conditions:-
  - 1. The wages and conditions are to remain as at present.
- 2. Members of the claimant organization employed in and about the collieries of the respondents to this claim on the afternoon and night shifts shall be paid, in addition to their ordinary rates of pay, for working on such shifts, an additional 7½ per cent.
  - 3. All other claims are hereby dismissed.
- 4. This award shall operate on and from the 5th day of December, 1921.

# ACT OF PARLIAMENT ASSENTED TO.





FOR APPOINTMENT AS TELEGRAPH MESSENGER AT MELBOURNE AND SUBURBAN POST OFFICES.

Held 19th November, 1921.

HE candidates named hereunder were successful at the above examination.

The following should be noted:-

- (1) The names will remain on the Register of Qualified Candidates for eighteen months, that is, until and including 14t I June, 1923, when they must, in accordance with the law, be removed therefrom.
- (2) A candidate, though successful, cannot be appointed after he attains the age of sixteen years.
- (3) A candidate passes this examination if he secures at least half marks each in Handwriting and in Spelling; but those who have also gained half marks in Arithmetic at this examination will, if appointed, be eligible for promotion to a higher position in the General Division without further avanisation. further examination.
- (4) Those who have not secured at least 100 marks in Arithmetic will be required to pass a further examination in that subject after appointment, in order to become eligible for promotion. Promotion examinations are held half
- (5) Unless a Telegraph Messenger qualifies for promotion to a higher position before reaching the age of eighteen years he must retire from the Service on attaining that age.
- (6) Where two or more candidates secure the same number of marks, their order of merit is determined by the number of marks obtained for (a) Arithmetic, and (b) Handwriting, and, where these numbers are also equal, then by ballot

- (7) Upon appointment, a successful candidate must produce evidence of the date of his birth, and a medical certificate satisfying the Commissioner in whatever particulars he may determine as to the appointee's sound bodily health and freedom from physical defects. A successful candi-date should not undergo medical examination until instructed by the Commissioner to do so.
- (8) Before a successful candidate who is liable for training under the compulsory clauses of the Defence Act 1903-18 can receive appointment, he must produce evidence from his Area Officer that he has rendered the personal service required, or has been granted a temporary exemption.
- (9) Where a successful candidate does not reside within a reasonable distance of a suburban office at which the vacancy exists, the Commissioner reserves the right to appoint another boy, who, though having obtained less marks at the examination, resides in closer proximity to the post-office referred to.
- (10) If a successful candidate decline to accept an appointment offered to him, or fail to reply within seven days to a communication from the Commissioner or a Public Service Inspector, respecting his nomination to the Public Service, his name may be removed from the "Register of Qualified Candidates."
- (11) Should a successful candidate change his address, he should immediately notify the Secretary, Commonwealth Public Service Commissioner, Customs-house, Melbourne.
