## AN ORDINANCE

### Relating to Currency Coinage and Tokens.

**B**E it ordained by the Governor-General of the Commonwealth of Australia, with the advice of the Federal Executive Council, and in pursuance of the powers conferred by the *New Guinea Act* 1920, as follows:—

1. This Ordinance may be cited as 'the *Currency Coinage and Tokens Ordinance* 1922.

2. The Ordinances mentioned in the Schedule hereto are hereby Repealed.

3. In this Ordinance, unless the contrary intention appears' Definition.  
"Administration" means the Administration or Government of the Territory.

4.—(1.) Save as hereinafter provided, any person in the Territory German coinage and currency not to be used in the Territory. who makes use of or tenders or accepts or exchanges in the course of business or for any purpose whatsoever, any banknote or other paper-money issued by a German bank or any German currency or coinage of any nature whatsoever, shall be guilty of an offence.

Penalty: One hundred pounds or imprisonment for six months.

(2.) Any native may pay to the Administration in silver marks or other German coins any sums due by way of fees, taxes, or otherwise, and such coins may be accepted by the Administration at such rate of exchange as the Administrator from time to time authorizes.

5. All debts and moneys, due under a contract or otherwise, expressed in marks or fractions thereof, shall be regarded as if expressed in the same number of shillings or fractions thereof, and payment of such debts and moneys may be made in notes of the Commonwealth of Australia or in any coins which are legal tender in the Commonwealth of Australia.

Use of tokens  
and counters  
forbidden.

6.—(1.) Save as hereinafter provided, any person who issues any token or counter to any person in the course of trade, or in lieu of the payment or part payment in legal tender of moneys due to that person as wages or otherwise, shall be guilty of an offence.

Penalty : Fifty pounds or imprisonment for six months.

(2.) Any person who accepts any token or counter in the course of trade or in lieu of the payment or part payment in legal tender of moneys due to him as wages or otherwise, shall be guilty of an offence.

Penalty : Fifty pounds or imprisonment for six months.

(3.) Any religious or charitable body operating in the Territory, whose principal object is religious or secular education, may be exempted by the Administrator from the provisions of this section if he is satisfied that such body does not carry on a commercial or trading business or that its commercial or trading business is small in proportion to its other activities.

(4.) Any exemption granted by the Administrator in pursuance of the last preceding sub-section shall be notified in the *New Guinea Gazette*.

7.—(1.) In the application of the *Coinage Act 1909* to the Territory, section seven of that Act shall not be deemed to apply to any transaction or dealing between natives.

(2.) In that part of the coast of New Britain lying between Cape Merkus and Cape Dampier and in the hinterland adjoining that coast, the shell known as gold-lip (*Meleagrina margaretifera*) may be used by any person at the rate of twelve shillings a pair in place of legal tender for any purpose except for the purchase, sale, barter or exchange of Trocas shell.

## AN ORDINANCE

To amend the Natives' Contracts Protection Ordinance 1921.

BE it ordained by the Governor-General of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *New Guinea Act 1920*, as follows :—

1.—(1.) This Ordinance may be cited as the *Natives' Contracts Protection Ordinance 1922*. Short title and citation.

(2.) The *Natives' Contracts Protection Ordinance 1921* is, in this Ordinance, referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Natives' Contracts Protection Ordinance 1921-1922*.

2. Section three of the Principal Ordinance is amended by inserting the following new sub-section :— Amendment of s. 3 of No. 5 of 1921.

“(3) all other contracts the consideration for which either in money or goods exceeds Twenty pounds in value.”

3. Section five of the Principal Ordinance is amended by omitting from sub-section (1) the word “four” and inserting in its stead the word “three.” Amendment of s. 5 of No. 5 of 1921.

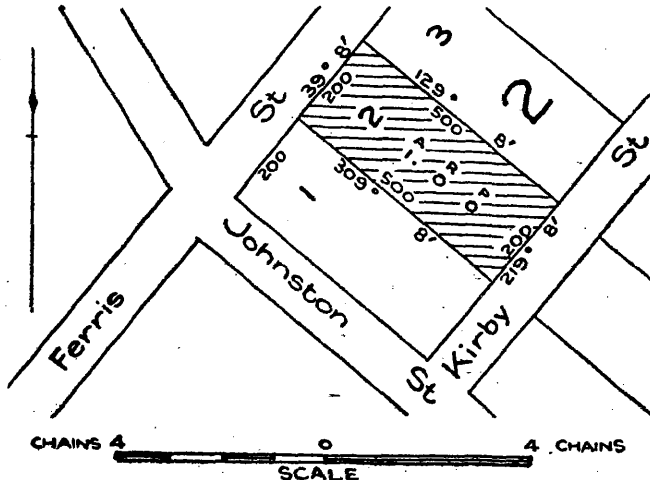

**A**N Examination, as above, will be held throughout the Commonwealth on Saturday afternoon, 4th November, 1922.

**NATURE OF EXAMINATION.**—The examination will be confined to the subject of \*Arithmetic—first four rules, simple and money; and, to be successful, a candidate will require to secure at least 100 of the 200 marks allotted.

\*Provided that Telegraph Messengers in Sydney who were appointed under Section 34b of the Commonwealth Public Service Act, and have not been granted the Qualifying Certificate of the Department of Education, New South Wales, will be required to undergo examination in Handwriting, Spelling, and Arithmetic, and to obtain at least half marks in each subject.
